1010 Park Avenue

Description: Heritage Development proposes the redevelopment of a 2.26 acre site assembled within the block bounded by 10th Street, Park Avenue, Grant Street, and Portland Avenue on the east edge of Downtown Minneapolis. The mixed use redevelopment, when complete, will provide 420 housing units and 37,952 sf of commercial space served by 577 enclosed off street parking spaces. 133 housing units in linked towers of 11 and 22 floors will be constructed in the first phase. The remaining 287 housing units will be constructed in linked towers of 25 and 40 floors during the final phase. One building on the site 619 10th St. S, is locally designated and is listed on the National Register of Historic Places. This building will not be altered during the redevelopment.

DeLaSalle Athletic Facility

Description: The project is an addition of a regulation size football field at the DeLaSalle High School campus on Nicollet Island. The use of the field will be shared by DeLaSalle High School and the Minneapolis Park and Recreation Board. The new field, when not used for football, will provide one regulation size soccer field or three junior soccer fields. The use of this new football and soccer facility will be shared by DeLaSalle and by the Minneapolis Park and Recreation Board (MPRB). The athletic field will be built on two parcels of land presently divided by Grove Street, one owned by DeLaSalle, and one owned by the MPRB. The portion of the existing Grove Street right-of-way between Nicollet Street and East Island Avenue dividing the parcels would be vacated for the Project. The project site is located within the St. Anthony Falls Historic District.

Mankato Regional Airport Runway Expansion

Description: The Mankato Regional Airport proposed project is to expand Runway 15-33 and parallel taxiway 1,200 feet to the northwest. The proposed project would lengthen the runway and taxiway from 5,400 feet to 6,600 feet. The runway would be 100 feet wide and the taxiway 50 feet wide.

SCOPING EAW COMMENT EXTENSION

Red Path Heifer, LLP (Special Two-Week Public Comment Extension)

Description: Redpath Heifers, LLP (proposer), is proposing to construct a new dairy heifer feedlot containing three 1,212-foot long by 210-foot wide free stall barns. Manure from these buildings will be stored in a concrete structure below the building 1,212-foot long by 210-foot wide by 13 feet deep. In addition, a 500-foot long by 300-foot wide covered feed storage pad will be built. When completed, the facility will have a maximum physical capacity to house 14,000 dairy heifers (9,800 animal units (AU)).

AMENDED SCOPING DECISION

Highway 14 improvements

The Minnesota Department of Transportation has amended its scoping decision on the project to improve Minnesota Trunk Highway 14 between New Ulm and North Mankato. Mn/DOT issued a Scoping Decision Document on this project in May, 2003. Since that time additional analysis and public and agency involvement have resulted in changes to the alternatives identified for study in the Draft EIS. Those changes are described in the Amended Scoping Decision Document being made available by Mn/DOT. Briefly, the changed features include the following:

- The west project limit will be extended to include consideration of improvements to the TH 14 bridge over the Minnesota River in New Ulm;
- The alternative which carried TH 14 on existing alignment through Courtland is eliminated from consideration in the EIS;
- The Courtland Northern Bypass #2 is eliminated from consideration in the EIS;
- The alternative which carried TH 14 on existing alignment through Nicollet is eliminated from consideration in the EIS.

University of Minnesota Football Stadium

Description: The University of Minnesota has prepared a Draft Environmental Impact Statement for a new 50,000 seat open air on-campus football stadium, including site and associated public infrastructure improvements with Minneapolis in Hennepin County, Minnesota. The Stadium Project is located on the existing Huron Boulevard parking lots, in close proximity to Mariucci Arena and the Williams Arena/Sports Pavilion complex.

Elk River Sanitary Landfill Expansion

Description: The Minnesota Pollution Control Agency (MPCA) has prepared a Draft Environmental Impact Statement (EIS) on the proposal to expand the Elk River Landfill (ERL), located in the city of Elk River, Sherburne County. Elk River Landfill, Inc., a wholly-owned subsidiary of Waste Management, Inc., owns and operated a landfill under Minnesota Solid Waste Permit Number SW-74. ERL is also licensed and permitted by Sherburne County and the city of Elk River. ERL proposes to expand operations at its existing mixed municipal solid waste (MSW) disposal facility by developing 73.7 acres currently used by a gravel mining operation located immediately south, adjacent to, and as a contiguous part of the existing Landfill property. The proposed Landfill expansion, known as the Southern Development Area (SDA), will provide approximately 15,000,000 cubic yards of additional MSW disposal capacity and extend Landfill operations for 16 to 20 years, depending upon incoming waste volumes. This Draft EIS addresses the potential for environmental impacts on ground water, landfill gas emissions, stormwater

run-off, visual effects, alternatives, and economic and social impacts. Mitigation measures are recommended for unavoidable environmental impacts.

The public comments period on the Draft EIS will end December 1, 2005. The MPCA will hold a public informational meeting on the Draft EIS at the Uppertown Conference Room, 13065 Orono Parkway, Elk River, Minnesota, on Tuesday, November 15, 2005, from 6:30 p.m. to 8:30 p.m. Timely comments on the Draft EIS will be responded to in a written response document that will, along with any needed revisions, be incorporated into the Final EIS. The Final EIS will be publicly distributed, and then brought to the MPCA Citizens' Board (Board) for a decision on the adequacy of the EIS. All persons on the project mailing list will be notified in advance of the Board adequacy decision meeting.

**In the Matter of an Xcel Energy Application for a Route Permit for the Eastwood 115kV/115kV Transmission Line Project in the Blue Earth County.
PUC Docket No. E002/TR-05-1192; EQB Docket No. 05-95-TR-Eastwood**

PLEASE TAKE NOTICE that the Environmental Assessment (EA) required for the above project has been completed. The EA addresses the potential human and environmental impacts of the proposed high voltage transmission line (HVTL) project.

Project Description. Xcel Energy has proposed to construct a double-circuit 115 kV HTVL about 3.5 miles long in Lime and Mankato Townships in Blue Earth County. The line taps into the Loon Lake-Summit 115 kV transmission line just south of Mankato Airport and terminates on its south end at the Eastwood Substation. The project is part of a series of transmission projects that will allow the electrical system to support the interconnection of the Mankato Energy Center into the Wilmarth Substation.

Regulatory Framework. The Minnesota Legislature transferred the authority to permit high voltage transmission lines from the Environmental Quality Board (EQB) to the Public Utilities Commission (PUC) on July 1, 2005. EQB Energy Facility Permitting staff was transferred to the Minnesota Department of Commerce (DOC), where they continue to coordinate the routing process through the PUC final decision.

The DOC released the EA on October 17, 2005. Copies of the permit application and the EA are available for public review at the Mankato City Center. The EA and other project-related documents may also be found on the web at:

Metropolitan Airports Commission/Assessment of Environmental Effects of the 2006-2012 Capital Improvement Program for MSP

Minnesota Statutes 1988, Chapter 664, requires the Metropolitan Airports Commission (MAC) to prepare an Assessment of Environmental Effects (AOEE) for projects in the Commission's seven-year Capital Improvement Program (2006-2012) for airports included in its system.

In accordance with Minnesota Statutes 1988, Chapter 664, one project scheduled for 2006 at Minneapolis - St. Paul International Airport (MSP) requires the preparation of an EAW and a public hearing — Phase 1 of the 2020 Development Program, which includes expansion of the Humphrey Terminal and extension of some taxiways. Minnesota Rules, Chapter 4410.1300, allow a Federal environmental assessment (EA) to substitute for an EAW. A 2015 Terminal Expansion Project EA that included Phases 1 and 2 of the 2020 Development Program was prepared and circulated for comment on July 1, 2005. All other projects in the MSP 2006-2012 CIP that require an EAW under Chapter 664 have been assessed for their environmental effects as part of the 2010 Long Term Comprehensive Program in the Final EIS for the Dual Track Airport Planning Process completed in 1998.

An AOEE relating to construction projects at MSP has been prepared. Assessment for St. Paul Downtown, Flying Cloud, Crystal, Anoka County-Blaine, Lake Elmo and Airlake airports did not need to be prepared since the Capital Improvement Program and Plan has not changed from the previous year or the changes have been addressed in approved EAW/EA/EIS documents or have minimal environmental effects.
