This redevelopment project will result in approximately 588,759 square feet.

#### **Brightsdale Dam River Restoration**

**Project description:** The Brightsdale Dam was constructed in 1903 as part of a hydropower facility and was removed in 2003. The Minnesota DNR, Fillmore SWCD, Eagle Bluff Environmental Learning Center, and private landowners are working together to restore the Root River back to its pre-dam location to reduce streambank erosion and improve channel stability and habitat quality. This project will restore approximately a half mile of the Root River to its historic location and be used for educational purposes for the public and students attending Eagle Bluff Environmental Learning Center.
