## EQB Chair approves new EAW form for animal feedlots

At the Environmental Quality Board's meeting on December 18, 2024 the EQB Chair approved a new Environmental Assessment Worksheet form for animal feedlots as requested by the Minnesota Pollution Control Agency (MPCA) who serves as the responsible governmental unit for the majority of animal feedlot projects. The Chair also revoked approval of the 2000 version of the form, but any project actively using the 2000 version may continue to do so. The new form was designed by the MPCA to be more efficient and aligns with the standard EAW form. It can be found on the EQB's website and also on the MPCA's website.
