1. Welcome and roll call

Chair Nancy Daubenberger called to order the regular meeting of the Environmental Quality Board.

3. Executive Director's report

Erik Cedarleaf Dahl – Interim Executive Director, EQB

 Odyssey project: This winter, we will be launching a new EQB Monitor submittal service. Responsible governmental units (RGUs) and consultants for RGUs will use the service to submit environmental review notices. Other governmental agencies will use the service to submit other general notices for publication in the EQB Monitor as well. In addition to the new submittal service, we will be launching a new webpage with a searchable database of environmental review projects with access to the associated documents.

- Obsolete rules report: On November 30, EQB submitted a report to the Minnesota Legislature on obsolete, unnecessary, and duplicative rules within Minnesota Rules, chapter 4410. The report collected public feedback for 30 days and identified items for further review during EQB's next rulemaking and items for further review during the 2024 Mandatory Categories Report.
- EQB posted the Executive Director position which closes December 30.
- EQB is seeking applications for the congressional district 3 board seat.
- EQB will be co-hosting a water meeting on the "Social & Health Impacts of Changing Water Resources and Ecosystems" in partnership with the University of Minnesota on January 24.

4. Summary of Subcommittee for Pilot Program Implementation discussion and recommendations

Subcommittee for Pilot Program Implementation (SPPI) Chair Nicholas Martin gave a summary of the implementation of the pilot program to incorporate climate information in the environmental assessment worksheet (EAW) form. The subcommittee recommends the proposed changes to the EAW form.

5. Summary of Environmental Review Implementation Subcommittee discussion and recommendations

Environmental Review Implementation Subcommittee Chair Strommen gave a summary of the results of the pilot program. The subcommittee recommends the proposed changes to the EAW form.

6. Approval of December 2022 Environmental Assessment Worksheet form

EQB Director of Environmental Review Denise Wilson presented the resolution and the draft implementation plan. She also thanked the interagency climate technical team.

The board held a discussion and two members of the public commented.

Board Member Van Amburg proposed an amendment to strike the word "potentially" out of the sentence "climate change is identified as a potentially significant environmental issue."

The board considered the amended resolution. Board Member Van Amburg motioned to approve the amendment to the resolution. Board Member Strommen seconded. In favor: Arnold, Bakken, Bauerkemper, Daubenberger, Foster, Hince, Konar-Steenberg, Martin, Nelson, Petersen, Strommen, Van Amburg. Opposed: none. Excused: Grove, Kessler, Malcolm, Roberts-Davis. Motion passes.

The board considered the final, amended resolution. Board Member Konar-Steenburg motioned to approve the resolution. Board Member Hince seconded. In favor: Arnold, Bakken, Bauerkemper, Daubenberger, Foster, Hince, Konar-Steenberg, Martin, Nelson, Petersen, Strommen, Van Amburg.

Opposed: None. Excused: Grove, Kessler, Malcolm, Roberts-Davis. Motion passes. The EQB chair formally approved updates to the EAW form.

7. Summary of the Continuous Improvement Process for Environmental Review (discussion item)

EQB Environmental Review Program Administrator Kayla Walsh presented background information on developing a continuous improvement process. Minnesota Management and Budget Senior Management Consultants Karen Gaides and Mariyam Naadha spoke about the research and engagement aspects of the project. The board discussed the process.
