## EQB planning surveys to collect additional ER data

We recently updated the data management plan for the environmental review program. Within the update, new information/metrics are identified as necessary to collect for us to better understand the implementation of the program and be able to assess the effectiveness of the program. In order to collect this information, the EQB is planning to survey the RGU contacts for EAW projects that are noticed in the EQB Monitor. With this project we want to better understand the amount of time an EAW takes to complete; the interactions between RGUs and project proposers; engagement efforts; and other information. We plan for these to be simple and take no more than 5-10 minutes to complete. The information we can gain from these surveys will improve the understanding of how the program is being implemented by RGUs and help the EQB determine if improvements to the program could benefit program participants.

**Project description:** Yale Holdings, LLC is proposing a mixed-use development along Trunk Highway (TH) 169 within the City of Garrison, MN. This proposed development is on approximately 122 acres and includes up to 189 single family homes (aka cottages), 86 condos, and a hotel/lodge with 144 rooms. Construction will also include stormwater infrastructure, internal roads, and utilities.

### **Shakopee Gravel Redevelopment**

Location (city/township; county): Shakopee; Scott

**Process: EAW** 

Step: EIS need decision

Responsible governmental unit decision: Negative (EIS not ordered)
Responsible governmental unit record of decision date: June 25, 2024

**Project description:** A residential and mixed-use development is proposed on approximately 146 acres southwest of the intersection of Mystic Lake Dr. (County Highway 83) and 17th Ave E (County Highway 16), in Shakopee, Minnesota. This proposed development is located at the site of a sand and gravel pit and includes 223 single family homes, 98 attached townhomes, up to 534 apartment units, 174,300 square feet of mixed commercial uses, and approximately 24 acres of open space. Construction will also include a water treatment plant owned and operated by the Shakopee Public Utilities Commission, stormwater infrastructure, internal roads, and utilities.

## **West Transit Village**

**Project description:** The West Transit Village (WTV) project is north of 2nd Street SW and east of Avalon Cove Court NW in Rochester, Olmsted County, MN. The site consists of two parcels and approximately 15 acres with an existing surface parking lot. The WTV project proposes to replace the surface lot with a new transit plaza consisting of a public

park-and-ride lot, a Mayo Clinic employee parking ramp, and mixed-use developments. The project is located at the westernmost stop of the proposed Rochester Bus Rapid Transit (BRT) (the Link BRT) project.
