

### [Veit Mining Expansion](#)

**Location (city/township; county):** Rogers; Hennepin

**Process:** EAW

**Step:** EAW available

**End of comment period:** October 3, 2024

**Project description:** Veit & Company, Inc. (Veit) proposes the construction and operation of a sand and gravel mine on a parcel located within Section 16, Township 120N, Range 23 W, Hennepin County, Minnesota. The proposed site contains sand resources which will be mined and processed for use in redi-mix concrete, asphalt pavement, and as base material for private and public construction projects in the area. The mining operation would occur in seven phases over the approximately 45-acre site.

## Wabasha Barge Facility

**Location (city/township; county):** Wabasha; Wabasha

**Process:** EIS

**Step:** Final EIS

**End of comment period:** September 17, 2024

**Project description:** The City of Wabasha, in cooperation with the Wabasha Port Authority, is proposing to construct a commercial port facility on the Mississippi River in the City of Wabasha, Minnesota. The 8.2-acre Wabasha Barge Facility would facilitate the transfer of materials, to include but not limited to dredge material and other commodities, from river barges to trucks for transport to off-site facilities. The City of Wabasha would own the project site and contract out the port operations and transportation of materials.
