### **VIII. Tour of Syngenta Seedcare Institute**

#### IX. Farm Tours

Sarah Foltz Jordan led Committee members on tours of three adjacent organic fruit and vegetable farms (Open Hands Farm, Spring Wind Farm, and Little Hill Berry Farm) with pollinator conservation practices installed as well as a large-scale grain farm (Kimber Contours) that is in the process of converting into an organic operation.

#### X. The Role of NRCS in Pollinator Conservation

Karin Jokela (Xerces Society) and Matt (NAME?) presented on several of the programs available through the NRCS that can provide pollinator habitat. One major point they made is that the NRCS is short-staffed, and they don't have the capacity to meet the demand for technical assistance for pollinator project funding.

### XI. Pollinator Habitat Subcommittee Report

Sarah Foltz Jordan, Dan MacSwain, and Dan Schutte walked through the working document that the Habitat Subcommittee had begun. The Committee discussed the direction of the document and agreed that the Subcommittee should continue moving forward to refine recommendations.
