The existing site currently has two 2-story buildings; the proposed development concept would consist of warehousing, retail, office, and 590 residential units which requires a mandatory Environmental Assessment Worksheet (EAW).

Project Description: The Adelmann Family Property is located along County State Aid Highway 2 (260th Street East) and I-35, east of Elko New Market in Scott County. The property is comprised of six parcels totaling 242.5 acres which define the AUAR Study Area. Proposed future land uses within the AUAR Study Area include business/limited industrial park, commercial, medium density residential, and public road right-of-way. Non-developed acreage will remain as wetlands, wooded/forested, and brush/grassland. Phased development is proposed to occur over several years, beginning with portions of the property located adjacent to the CSAH 2 (260th Street East) corridor. Public comments were received and responded to. The city formally adopted the AUAR on March 24, 2022.

137 Line Extension 115kV Project

Location: Hoyt Lakes and Babbitt, Saint Louis County

Process: Alternative Review

Notice Title: Notice of Environmental Assessment

Notice Description: The City of Hoyt Lakes is conducting a local review and permit process for the proposed 137 Line Extension, 115 kV High Voltage Transmission Line. Hoyt Lakes will accept written comments on the Environmental Assessment (EA) until May 3, 2022. The EA will be available for review at the Hoyt Lakes Municipal Building at 206 Kennedy Memorial Drive, Hoyt Lakes, MN 55750 and on the City website at www.hoytlakes.com.

Project Description: The proposed 137 Line Extension 115 kV Project is a 115 kV High Voltage Transmission Line (HVTL) in the City of Hoyt Lakes and the City of Babbitt. Approximately 3 miles of new 115 kV line will be constructed along the existing 1 Line transmission line corridor and approximately 5 miles of new corridor will be constructed. This will extend the existing 137 Line 115 kV Line from the Peter Mitchell Mine to the Mesaba Junction Switching Station. Minnesota Power has requested the Minnesota Public Utilities Commission allow the City of Hoyt Lakes to conduct a local review and permit approval process as is allowed under Minnesota Statutes Chapter 216-E.05. The City of Hoyt Lakes will evaluate the potential environmental effects of the project through an Environmental Assessment (EA). Project Description: Dodge County Wind, LLC (DCW or applicant), a wholly-owned subsidiary of NextEra Energy Resources, LLC proposes to construct, own, and operate the up to 259 megawatt (MW) Dodge County Wind Farm in Dodge and Steele counties and approximately 26.8 miles of 161 kV transmission line in Dodge and Mower counties (Project). The Project would include a mix of up to 79 2.52 MW and 3.4 MW turbines. The 11 GE 2.52 MW turbines have a total height of 486.5 feet from ground to tip. DCW proposes to use two configurations of the GE 3.4 turbines: eight (8) with a total height of 495 feet, and 60 with a total height of 551 feet. Additionally, the Project will include a collector substation, collection lines, an operation and maintenance building, a permanent meteorological tower, and gravel access roads. The associated 161 kV transmission line would connect the wind farm to the Pleasant Valley substation in Mower County.

- Are there any unique characteristics of the proposed site or the project that should be considered?

- Are there other ways to meet the stated need for the project, for example, a different size project or a different type of facility? If so, what alternatives to the project should be studied in the EA?
- Are there any items missing or mischaracterized in any of the applications, or issues that need further development?
