#### **Bee Lucky for Pollinators**

The EQB collaborated with the Minnesota Lottery to create the Bee Lucky scratch ticket that features the endangered rusty patched bumble bee (*Bombus affinis*), Minnesota's state bee. The Interagency Pollinator Protection Team and Dr. Elaine Evans from the UMN Bee Lab worked together to provide the technical and scientific information that populates the Bee Lucky ticket landing page, and the Bee Informed box included in each ticket. This ticket will raise awareness about Minnesota's imperiled pollinators and ways to help them. Additionally, Bee Lucky ticket sales will generate lottery proceeds that support environmental projects, including improving pollinator habitat.

# NOTICE OF JOINT PUBLIC HEARINGS, DRAFT SITE PERMIT AVAILABILITY AND PUBLIC COMMENT PERIODS – WALLEYE WIND PROJECT

Date: May 4, 2021

Time: 1:00 PM and 6:00 PM

Location: Hearings will be conducted remotely.

On July 9, 2020, Walleye Wind LLC (Applicant) submitted applications to the Minnesota Public Utilities Commission to construct and operate a large wind energy conversion system (LWECS) in Rock County. In order to construct the Walleye Wind Project, the Applicant must be granted a certificate of need and a site permit from the Commission. The proposed project would entail construction of 40 wind turbines for a combined nameplate capacity of up to 109.2 megawatts (MW) in Martin, Luverne, Beaver Creek and Springwater townships in Rock County.

In addition to the wind turbines, the proposed project would consist of underground electrical collection and communication lines, a project substation, an operations and maintenance building, one permanent meteorological tower, gravel access roads, and a generation tie line of less than 500 feet connecting the project substation to Northern States Power's existing Rock County Substation. The Commission accepted the certificate of need and site permit applications in October 2020. This means the Applicant submitted all the information required to begin the review process. Minnesota Department

of Commerce Energy Environmental Review and Analysis have issued an environmental report on the project on March 31, 2021.

The Commission issued a draft site permit for the project on March 24, 2021. A draft site permit is a document prepared for public review and does not permit construction of the project. The public hearing is an opportunity for the public to ask questions and submit recommendations for the Commission's consideration in reaching its decision. After the public hearing and comment period, Administrative Law Judge James Mortenson will prepare a report including findings of fact, conclusions of law and recommendations for the Commission. The Commission will review all the information in the record and anticipates final decisions on the certificate of need and site permit applications in late summer or early autumn of 2021.

The Public Comment Period for the project will remain open until Thursday, May 20, 2021 at 4:30 PM. Comments may be submitted via:
