Bee Lucky for Pollinators

The EQB collaborated with the Minnesota Lottery to create the Bee Lucky scratch ticket that features the endangered rusty patched bumble bee (*Bombus affinis*), Minnesota's state bee. The Interagency Pollinator Protection Team and Dr. Elaine Evans from the UMN Bee Lab worked together to provide the technical and scientific information that populates the Bee Lucky ticket landing page, and the Bee Informed box included in each ticket. This ticket will raise awareness about Minnesota's imperiled pollinators and ways to help them. Additionally, Bee Lucky ticket sales will generate lottery proceeds that support environmental projects, including improving pollinator habitat.

South District Trunk Sanitary Sewer

Project Description: The City of Cottage Grove proposes to construct a new 5,095 foot South District Trunk Sanitary Sewer collection system that will serve the City's South District. The South District has yet to develop or tie into the City's sanitary sewer system. The proposed South District Trunk Sanitary Sewer will connect into the existing Metropolitan Council Environmental Services interceptor pipe that will convey the wastewater and treat it at the Eagles Point Wastewater Treatment Plant. The South District Trunk Sanitary Sewer will have a peak ultimate design flow of 6.705 million gallons per day.
