#### **Prospectors Loop Trail System Phase 2 (Connect Four)**

**Project description:** The Prospectors Trail Alliance (Club) is proposing four new ATV trail segments and a connecting spur as part of Phase 2 (also termed "Connect Four" segments) of the greater Prospectors Loop Trail for off-highway vehicles. Approximately 59.14 miles of trail are included. The segments provide new connections to existing trails and amenities in northern St. Louis County.

#### **Rosemount Industrial**

Location: Rosemount, Dakota County Process: Alternative urban areawide review (AUAR) Step: Draft order of review End of comment period: May 4, 2023

**Project description:** The AUAR study area encompasses an area totaling approximately 235 acres on 12 parcels in the City of Rosemount, Dakota County, Minnesota. Scannell Properties, LLC is proposing to redevelop the study area from existing agriculture to business park uses. One scenario is proposed for evaluation in the AUAR and includes multiple buildings for a total of 1.92 million square feet of proposed industrial development. The proposed development within the AUAR study area is anticipated to start Fall 2023.
