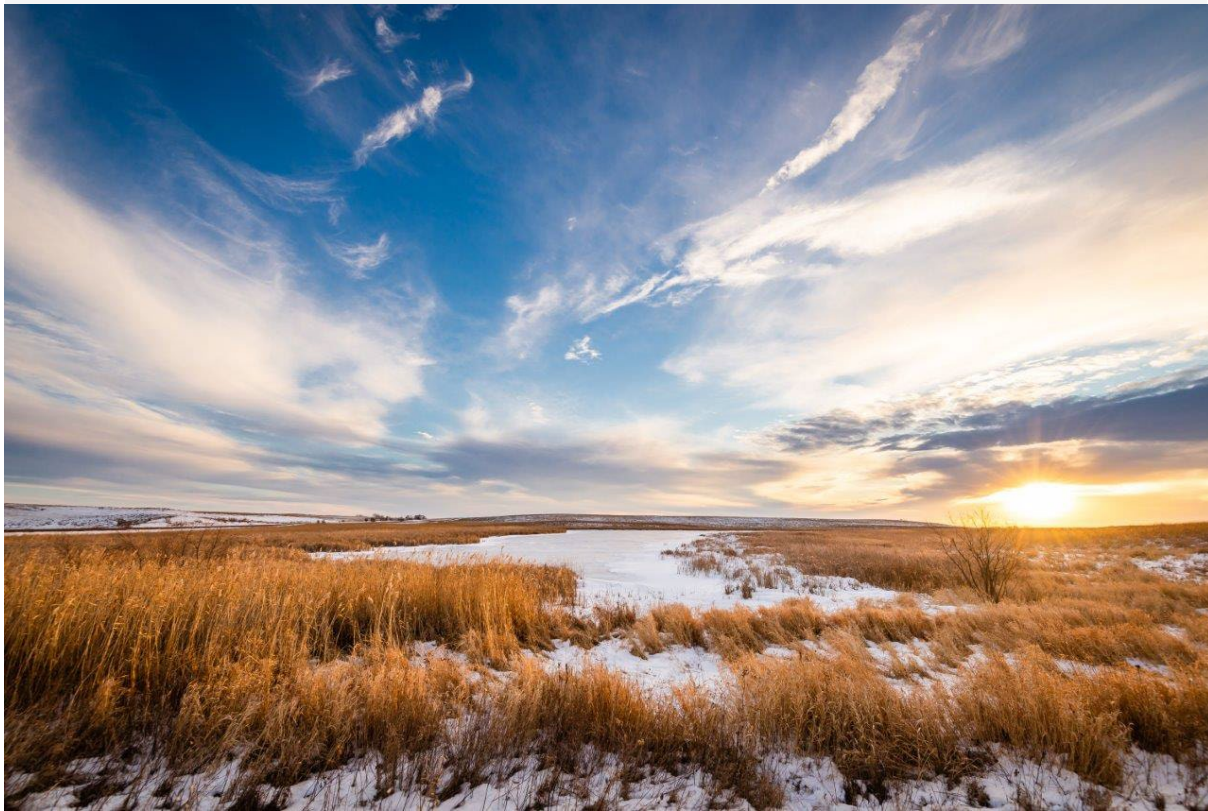

Chisago County State Aid Highway (CSAH) 17 (Athens Trail) Easterly Extension Project

Project description: The project will extend CSAH 17 (Athens Trail) as a two-lane rural roadway from CSAH 30 (Forest Boulevard) on the west to CSAH 14 (Lincoln Road) on the

east in Lent Township, Chisago County. The project will also construct single-lane roundabouts at the CSAH 17 (Athens Trail) intersections with CSAH 30 (Forest Boulevard) and CSAH 14 (Lincoln Road). Upper Riley Creek Ecological Enhancement Project from Highway 5 to Lake Susan, Chanhassen

Location: Chanhassen, Carver County

Process: Environmental assessment worksheet (EAW)

Project description: The Riley Purgatory Bluff Creek Watershed District, and the City of Chanhassen are proposing ecological enhancements along approximately 1.6 miles (approximately 28 total acres) of Upper Riley Creek, located between Highway 5 and Lake Susan (referred to as Upper Riley Creek; proposed Project). The proposed Project would improve the ecological functions along the reach of Upper Riley Creek and downstream Lake Susan by reducing stream bank erosion, reconnecting the creek to its floodplain, restoring habitat, and promoting diverse vegetation.
