Project Title: Flint Hills Resources Pine Bend – Propylene Storage and Distribution Project, Dakota County

Description: Flint Hills Resources Pine Bend is an existing refinery located at 13775 Clark Road in Rosemount, Minnesota. The refinery is owned and operated by Flint Hills Resources (FHR). FHR proposes to construct two propylene storage spheres and an associated rail loading rack at its refinery. FHR also proposes to expand its existing rail car staging area. These changes would allow FHR to store and distribute the refinery grade propylene that the Refinery already generates. This proposed Propylene Storage and Distribution Project would not result in an increase in the refinery's crude oil processing capacity.

EA Comment Deadline: February 20, 2013

Project Title: Interstate 35E MnPASS Project in the Cities of Little Canada, Maplewood and St. Paul, Ramsey County, Minnesota (SP 6280-367)

Description: The Minnesota Department of Transportation (MnDOT) is proposing a project in the cities of Little Canada, Maplewood, and St. Paul to rehabilitate the existing highway pavement and construct a new MnPASS lane from Little Canada Road to Maryland Avenue that would be designated as a new High Occupancy Toll (HOT) lane on the inside lane in each direction. The HOT lane is continued through the Cayuga Bridge project by restriping the shoulder to the Cayuga Street exit/entry.

This project includes rerouting a portion of the DNR Gateway Trail that currently crosses I-35E on the former Soo Line Railroad Bridge, located between Arlington Avenue and Maryland Avenue. The portion of this trail, which is located on MnDOT right-of-way, is considered a public recreational facility. This use is subject to the U. S. Department of Transportation Act of 1966 (49 U.S.C. 303) and 23 U.S.C. 138. Section 4(f) of the Act defines procedures required for addressing impacts to recreational and other public lands that would result from federally-funded transportation projects. In addition, the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) Act of 2005, Section 6009, allows for determinations that certain uses of Section 4(f) land will have no adverse effect (de minimis) on the protected resource. Section 6009(a) requires that a public notice and opportunity for review and comment be provided for projects that are determined to have de minimis impact. The Minnesota Department of Natural Resources (MnDNR) proposes a finding of de minimis impact to this multi-use trail. After an evaluation of the impacts of an action upon Section 4(f) resources, a finding can be made.

The Environmental Assessment (EA) describes the proposed project, impacts, and mitigation. This document also includes information on the Section 4(f) impacts and the preliminary *de minimis* finding, i.e., that adverse impacts to the recreational facility would not result from the proposed project. Any comments received regarding this issue during the public comment period will be taken by the Federal Highway Administration in making its final *de minimis* determination.

Two public hearings (open-house format) will be held for the proposed project. The first public hearing will be held on Thursday, February 7, 2013, from 4:30 p.m. to 6:30 p.m. at the Hiway Federal Credit Union, 840 Westminster Street, St. Paul, Minnesota. The second public hearing will be held on Monday, February 11, 2013, from 4:30 p.m. to 6:30 p.m. at St. Jerome Catholic Church, 380 East Roselawn Avenue, Maplewood, Minnesota. Written and oral comments will be accepted during the hearing as part of the public record.

FINAL EA AND FONSI AVAILABLE

This public comment period satisfies the state requirement of 30-day period for EAWs included in Minnesota Rules 4410.1600. Comment Deadline: February 20, 2013

Project Title: Crosswind Runway 18/36, Little Falls-Morrison County Airport, Little Falls MN

Description: The proposed action at Little Falls-Morrison County Airport includes the following:

- Counter-clockwise rotation and southward shift of Runway 18/36 for a total length of 2855 feet.
- Paving Runway 18/36 and installing runway edge lighting.
- Off-airport tree clearing.
- Approximately 18.5 acres of land acquisition.
- Enact airport zoning to meet State of Minnesota requirements.

The city of Little Falls prepared a Federal Environmental Assessment (EA) to evaluate the environmental effects of the proposed crosswind runway project. As permitted under Minnesota Rules, the Federal EA is intended as a substitute for a State Environmental Assessment Worksheet (EAW). The Federal EA addresses each environmental effect identified in the State EAW form, and has been circulated in place of an EAW form. Environmental impact analyses contained in the Federal EA were conducted in accordance with the Federal Aviation Administration (FAA) National Environmental Policy Act requirements, Minnesota Environmental Policy Act (MEPA) requirements, and Section 106 of the National Historic Preservation Act. A public hearing was held regarding the project on October 24, 2012, and the public comment period on the Draft EA closed on October 31, 2012.

The FAA has completed consideration of comments received on the Draft EA and has issued a Finding of No Significant Impact (FONSI) for the proposed project. The Final EA and FONSI found that the project is consistent with existing environmental policies and objectives as set forth in the National Environmental Policy Act of 1969 and will not significantly affect the quality of the human environment. The FAA issued a Section 106 finding of a *No Historic Properties Affected* for the project. The purpose of this Notice is to announce that the Final EA and FONSI are now available for public review and comment through February 20, 2013. Appendix R to the Final EA includes an abbreviated State EAW form which references relevant sections of the Federal EA for each environmental category. ALTERNATIVE URBAN AREAWIDE REVIEW (AUAR) UPDATE AVAILABLE

Revised AUAR Comment Deadline: February 4, 2013

Project Title: Oxbow Commons/610 Crossings AUAR

Description: The city of Brooklyn Park assisted by MFRA has updated an Alternative Urban Area-wide Review (AUAR) for development of approximately 230 acres bounded by Zane Avenue on the west, 101st Avenue North on the North, Regent Avenue on the east and Highway 610 to the south. This AUAR is the 4th AUAR completed in this area. The original AUAR was completed in 2001, the first update was competed in 2008, and the second update was completed in 2011. This latest update re-examines development of 40 acres for retail, multi-family, office and/or warehouse uses. All external roadways and infrastructure needed for the proposed development have already been constructed as part of development previously authorized by the prior three AUARs. The new development will be served by this existing infrastructure and all new roads and infrastructure will be internal to the development. There are no wetlands present on the undeveloped lands.

DRAFT EIS AVAILABLE

Project Title: Jordan Aggregates Proposed Mining Operation

Description: Jordan Aggregates, LLC proposes to mine sand and gravel from the property located at 17825 Valley View Drive in Sand Creek Township, Scott County, Minnesota. The mine will encompass 84.7 acres excavated up to 120 feet below the ground water into alluvial sand and gravel deposits, which serve as a local aquifer and is anticipated to operate for 25 years. When mining is complete a 36 acre ground water pond will remain. Reclamation will use on-site overburden materials and imported fill. The Draft EIS evaluates the impacts the mining operation will have on groundwater, traffic, and noise.

The public comment period on the Draft EIS will end February 20, 2013. Scott County will host a public information meeting from 5-7 p.m. on Wednesday February 6th, 2013, to discuss the Draft EIS. The meeting will be held in the SCALE Regional Public Safety Training Facility at 17706 Valley View Dr, in Jordan MN. Timely comments on the Draft EIS will be responded to in a written response document that will, along with any needed revision, be incorporated into the Final EIS. The Final EIS will be publicly distributed, and then brought to the Scott County Board of Commissioners for a decision on the adequacy of the EIS. All persons on the project mailing list will be notified in advance of the Board adequacy decision meeting.

Scott County, as stated in the notification, will publish the Draft EIS on January 21, 2013, on the County's Website and mail it to interested parties as prescribed. Consistent with the requirements of the Rule, Scott County will prepare and publish a press release for publication in a newspaper of general circulation in Scott County.

ROTENONE APPLICATION PROJECTS PLANNED BY DNR SECTION OF FISHERIES MANAGEMENT

The DNR Section of Wildlife Management is planning a rotenone treatment on the small wetland in the NW ¼ of the NW ¼ of Section 10, Township 110N, Range 22W, Rice County in the Boyd Sartell Wildlife Management Area.

This project involves the application of 2.5% synergized liquid rotenone, a federally and state registered pesticide, to eliminate less desirable fish species in the tributaries (including ditches) flowing into the above water bodies. The treatment will be conducted in the winter/spring of 2013. Endangered or threatened species are not present in the proposed treatment area. Project goals include removing undesirable fish species to improve water quality and wildlife habitat in these basins.

Rotenone application will be done by licensed pesticide applicators and by drip station. Target treatment concentration is 5 ppm. Benefits of the project will be improved water quality, re-establishment of desirable aquatic vegetation, reduction of plankton algae, and improved habitat for wildlife and waterfowl.
