SCOPING EAW AND DRAFT SCOPING DECISION DOCUMENT AVAILABLE

Comment Deadline: May 15, 2013

Project Title: Fargo-Moorhead Flood Risk Management Project

Project Description: The Minnesota Department of Natural Resources (DNR) is seeking public comments on the scoping documents for an Environmental Impact Statement (EIS) that will describe the potential environmental effects of a proposed flood diversion project in the Fargo-Moorhead Metropolitan Area. These documents provide information about the topics that are proposed to be included in the EIS for the proposed project. The DNR will consider the public comments before finalizing the scope of topics to be included in the EIS.

The Project would be located in the Fargo-Moorhead Metropolitan Area. It would include a diversion channel, connecting channel, tie-back levee/dam embankments, river control structures on the Red and Wild Rice (ND) Rivers, upstream floodwater staging area, levees and floodwalls, non-structural features, recreational features and environmental mitigation.

A 30-day public review and comment period begins April 15, 2013. The DNR invites public comments during the April 15-May 15, 2013, public review period. Comments on the scoping documents will be accepted until 4:30 p.m. May 15, 2013.

The DNR will hold a public information meeting Wednesday, May 8, 5:30-10:00 p.m., at the Courtyard by Marriott Fargo Moorhead & Moorhead Area Conference Center, 1080 28th Avenue South, Moorhead, MN. The meeting will offer an open house from 5:30 to 7:00 p.m. to provide informational materials and answer questions about the project and the scoping process. Formal presentations will begin at 7:00 p.m. followed by a public input session.

EIS ADEQUACY DECISION

Project Title: Perham Resource Recovery Facility Expansion Project.

On March 26, 2013, the Minnesota Pollution Control Agency (MPCA) Citizens' Board voted to approve the Findings of Fact, Conclusions of Law, and Order for the adequacy decision on the Environmental Impact Statement (EIS) for the proposed Perham Resource Recovery Facility Expansion Project (PRRF), Otter Tail County. The MPCA has determined that the PRRF EIS is adequate.

Notice of Finding of No Significant Impact (FONSI) and Approval and Release of Final Beltrami Island Land Utilization Project Comprehensive Conservation Management Plan

The Minnesota Department of Natural Resources (DNR) and U.S. Fish and Wildlife Service (USFWS) jointly announce the release of the Final Beltrami Island Land Utilization Project Comprehensive Conservation Management Plan. The plan, which sets forth management direction for 86,000 acres of Federal lands leased to the state for management in northwestern Minnesota, received DNR approval on March 12 and USFWS approval on March 29, 2013. A draft of the Plan was released for public review and comment from June 11—July 26, 2012, and a public open house was held in Warroad on June 27, 2012.

PLEASE TAKE NOTICE that the Minnesota Department of Commerce, Energy Facility Permitting (EFP) announces the release of the environmental assessment (EA) for the proposed SWTC Chaska Area 115 kV transmission line project.

The Environmental Assessment is a written document that describes the human and environmental impacts of the transmission line project (and selected alternative routes) and methods to mitigate such impacts. Applications for high voltage transmission line route permits under the alternative permitting process require a public hearing upon completion of the EA pursuant to Minn. R. 7850.3800. A portion of the hearing must be held in a county where the proposed project would be located.

The public hearing will be noticed separately and in accordance with Minnesota Statutes, section 216E.03, subdivision 6.
