Project Title: Dakota Path First Addition, Dakota County

Description: The proposed residential development at 1290 and 1310 Cliff Road (former Parkview Golf Course) will offer diverse housing types geared toward meeting the lifecycle housing needs of current and future residents of the community. The proposed project includes 173 single-family units, a 100-unit age-restricted multi-family building, private pool and pool house, and interconnected trail and open space network throughout the neighborhood.

REVISED AUAR ADOPTED

Project Title: New Brighton Exchange Alternative Urban Areawide Review (AUAR) Update Adopted, Ramsey County

Description: The City of New Brighton is going through its second update of an Alternative Urban Area-wide Review (AUAR). In 2002, the City of New Brighton began acquiring properties in an effort to redevelop approximately 100 acres in the northwest quadrant of I-35W and I-694. After ten years the City has acquired all clean, contaminated, and suspected contaminated properties. Redevelopment of the site as parks, residential, commercial, and mixed land uses is the City's Preferred Alternative. The AUAR Update was sent to review agencies on September 3, 2012. The New Brighton City Council adopted Resolution #12-081 adopting the AUAR Update for the New Brighton Exchange Project on October 23, 2012.
