

CSAH 51 (UNIVERSITY AVENUE) ENVIRONMENTAL ASSESSMENT, PROGRAMMATIC SECTION 4(F), and PUBLIC HEARING

Project Title: County State Aid Highway (CSAH) 51 (University Avenue) Transportation Improvements, Coon Rapids and Blaine, Anoka County, Minnesota (S.P. 002-651-007) Project Description: In 2014, Anoka County will initiate the reconstruction of CSAH 51 (University Avenue) in the Cities of Coon Rapids and Blaine from CSAH 12 (109th Avenue NE) to CSAH 14 (125th Avenue). Review and approval of the CSAH 51 Environmental Assessment/Environmental Assessment Worksheet (EA/EAW) and Programmatic Section 4(f) document was completed by the Minnesota Department of Transportation and the Federal Highway Administration in fall 2013. The County encourages the public to attend a Public Hearing and Open House for the proposed Transportation Improvements.

The Open House and Public Hearing will be held December 11, 2013 from 4:30 p.m. to 6:30 p.m. (formal public hearing from 5:30 to 6:00 p.m.) at the City of Coon Rapids, 11155 Robinson Drive, Coon Rapids, MN 55433.

The proposed project includes reconstruction of 1.85 miles of a primarily rural two-lane roadway to a four-lane, urban roadway with center median; construction of storm sewer, storm water treatment ponds; and construction of an off road bituminous trail and sidewalk. As part of the project, intersection improvements will include a realignment of 111th Avenue to eliminate an offset intersection and turn lanes will be constructed at the intersections with 111th Avenue, 113th Avenue, 115th Avenue, 117th Avenue, and 121st Avenue. This project will impact wetlands and require the acquisition of right-of-way. The project will also impact 12,600 square feet of the Northdale Middle School Recreational Facility, a Section 4(f) resource. The tentative schedule for right-of-way acquisition and construction, dependent upon federal approvals, is Spring 2014 and Summer 2014, respectively.

The purpose of the open house is to answer questions about the proposed project. Maps, drawings and other pertinent information, including the Environmental Assessment/ Environmental Assessment Worksheet (EA/EAW) will be available. The EA/EAW is the federally-required document that outlines social, economic and environmental impacts of the proposed project. The public is encouraged to discuss the project with staff and the consultant during the open house portion of the event.

The purpose of the public hearing is to collect comments and feedback on the EA/EAW document. During this portion of the meeting, the public is encouraged to provide oral or written comments on the document. These comments will be documented during the public hearing. Comments collected during the hearing will be incorporated and responded to in the final EA/EAW. Staff from the county is not permitted to answer questions during the formal hearing.

During the public hearing, meeting participants will have the opportunity to submit verbal comments that will become part of the official public hearing record. The hearing will be extended appropriately to accommodate verbal comments.

Project Title: Sturgeon Lake Road Improvements EA/EAW Update – Notice of Availability Project Description: As the designated Responsible Governmental Unit (RGU), the City of Red Wing in coordination with the Prairie Island Indian Community (PIIC) has prepared an Environmental Assessment (EA)/Discretionary Environmental Assessment Worksheet (EAW) Update for improvements to Sturgeon Lake Road in the city of Red Wing.

The Sturgeon Lake Road project that is the subject of this environmental review document was previously evaluated in an EA/Discretionary EAW published in 2005. A Finding of No Significant Impact (FONSI) and Negative Declaration were issued in 2006, and no action has been taken on the project since that time. The update document focuses only on the changes between the project evaluated in the 2005 EA/EAW, and the currently proposed project.

The City of Red Wing and PIIC propose to realign approximately 4,300 feet of Sturgeon Lake Road, and build an overpass spanning the existing railroad. The project would address delay and safety issues with the existing at-grade railway crossing. Safety will also be improved through the addition of turn lanes at key intersections. A multi-use trail would be constructed to better facilitate non-motorized travel.

Copies of the Draft EA/EAW Update will be distributed to agencies on the current Minnesota Environmental Quality Board list. The Draft EA/EAW Update may be accessed electronically on the project website (<u>http://www.red-wing.org/sturgeonlake.html</u>) and paper copies will be available for review at the Red Wing Public Library (225 East Avenue, Red Wing).

Final EIS Available

Project Description: Jordan Aggregates, LLC proposes to mine sand and gravel from the property located at 17825 Valley View Drive in Sand Creek Township, Scott County, Minnesota. The mine will encompass 84.7 acres excavated up to 120 feet below the ground water into alluvial sand and gravel deposits, which serve as a local aquifer and is anticipated to operate for 25 years. When mining is complete a 36 acre ground water pond will remain. Reclamation will use on-site overburden materials and imported fill. The Draft EIS evaluates the impacts the mining operation will have on groundwater, traffic, and noise.

Interested persons may submit written comments on the adequacy of the Final EIS for a period of 30 days. The public comment period regarding the adequacy of Final EIS will end December 26, 2013.

Scott County, as required under 4410.2700 Subp. 3, will distribute copies of the Final EIS on November 25, 2013 on a compact disc to all persons which received the Draft EIS or submitted substantive comments on the draft EIS. The FEIS will also be available on the County's Website. Scott County will prepare and publish a press release for publication in a newspaper of general circulation in Scott County.

The Final EIS will be publicly distributed, and then brought to the Scott County Board of Commissioners for a decision on the adequacy of the FEIS. All persons on the project mailing list will be notified in advance of the Board adequacy decision meeting.

In the Matter of the Applications for a Route Permit for the MP Deer River HVTL Project PLEASE TAKE NOTICE that the Minnesota Department of Commerce, Energy Environmental Review and Analysis (EERA) announces the release of the environmental assessment (EA) for the proposed MP Deer River HVTL project.

Notice of Permit Decision in the Matter of the Route Permit Application by Northern States Power Company and Great River Energy for the Southwest Twin Cities Chaska Area 115 kV Transmission Line Project in Carver and Scott Counties

In an order issued October 15, 2013, the Minnesota Public Utilities Commission determined that the environmental assessment and record created at the public hearing adequately addressed the issues identified in the scoping decision for the project, and issued a high voltage transmission line route permit to Northern States Power Company and Great River Energy for the Southwest Twin Cities Chaska Area 115 kV Transmission Line Project.

The route permit authorizes Northern States Power Company and Great River Energy to upgrade an existing 69 kV transmission line and to construct a new 115 kV line in Carver and Scott Counties.
