Project Title: Highway 52/65th Street Interchange Project (SP 5508-117)

Description: The proposed project includes construction of on and off ramps connecting the existing 65th Street overpass to Highway 52, creating a new full access interchange with folded access ramps on the north side of 65th Street. Two new stormwater ponds will be constructed within the ramp loops. The project also includes roadway expansion and improvements along 65th Street between Highway 52 and approximately 0.1 miles west of Freedom Drive, realignment of the west frontage road in the interchange's northwest quadrant, construction of northbound and southbound Highway 52 auxiliary lanes between 55th Street and 65th Street, and a pedestrian trail along the south side of 65th Street between Highway 52 and the realigned west frontage road.

Description: The purpose of this EA/EAW is to document impacts for the construction of an interchange. The project includes lowering the grade on Highway 15, the construction of a bridge to carry CSAH 120 traffic over Highway 15, exit and entrance ramps, multi-use trail connections, a storm water pond and a screening berm.

Project Title: Perham Resource Recovery Facility Expansion Project

Description: The Minnesota Pollution Control Agency (MPCA) is public noticing a Scoping Environmental Assessment Worksheet as the basis for the scoping process for the voluntary Environmental Impact Statement (EIS) for this project.

An EIS is being prepared by the MPCA on a proposal by the Prairie Lakes Municipal Solid Waste Authority to modify the Perham Resource Recovery Facility by adding a second heat boiler, as well as a material recovery facility at the site. The expansion would increase the municipal solid waste processing capacity of the facility from 116 to 200 tons per day.

The public comment period on the Scoping EAW and Draft Scoping Decision Document will end January 5, 2012. There will be a public meeting held at the Perham City Council Chambers, 125 2nd Avenue NE, Perham, Minnesota, on Thursday, December 14, 2011, from 6:30 p.m. to 9:00 p.m. The event will begin with informal discussions from 6:30 to 7:30 p.m. This public meeting will be open to the public for interested parties to comment and ask questions regarding the Draft Scoping Document for the preparation of the EIS.

NOTICE OF APPLICATION ACCEPTANCE AND COMMENT PERIOD

In the Matter of the Site Permit Application of Community Wind South, LLC for a Large Wind Energy Conversion System in Nobles County

PUC Docket Number: IP-687/WS-11-863

PLEASE TAKE NOTICE that Community Wind South, LLC (CWS) has applied to the Minnesota Public Utilities Commission (Commission) for a site permit to build and operate the Community Wind South, LLC Wind Farm, a 30.75 megawatt large wind energy conversion system (LWECS) in Nobles County. The Commission issued an order accepting the site permit application on November 14, 2011.

Site Permit Review Process. Minnesota Department of Commerce, Energy Facility Permitting (EFP) staff, on behalf of the Commission, is initiating the permit review process for the Community Wind South, LLC Wind Farm under the Wind Siting Act (Minnesota Statutes chapter 216F) and Wind Permitting Rules (Minnesota Rules chapter 7854). Upon completion of this process, the EFP staff will present the record of this matter to the Commission for a final permit decision.

Comment Period. EFP staff is soliciting comments on issues that should be considered in developing a draft site permit for this project. Such issues include unique characteristics of the proposed site or project that should be considered and items that may be missing or mischaracterized in the site permit application. **EFP staff will accept written comments on issues to consider in developing a draft site permit until 4:30 p.m. on Friday, December 30, 2011.** Please include the PUC Docket No. IP-687/WS-11-863 on all comments. If the Commission issues a draft site permit for public review and comment, a public meeting will be held in the project area and members of the public will have an opportunity to ask questions and provide additional comments. Project Description. The proposed Community Wind South Wind, LLC project site encompasses 3,080 acres and is located in Nobles County in the townships of Summit Lake (Sections 17-20, 30) and Larkin (Sections 13, 23-24), located approximately two miles south of Wilmont (see accompanying map). CWS proposes to install 15 REPower 2.05MW turbines (model MM92) for a rated nameplate capacity of 30.75 MW's. The wind turbines will be placed on top of free standing tubular steel towers up to 100 meters (328 feet) tall. The three bladed rotor assemblies will be 92.5 meters (303.5 feet) in diameter.

The turbines will be connected by underground electrical cables and supervisory control and data acquisition (SCADA) fiber optic lines for communication purposes. Other associated facilities include gravel access roads to the turbines, pad mounted transformers, a fenced-in project collection yard, two sets of underground electrical cable (34.5 kV) extending approximately 19,908 feet from the CWS project collector yard to the Nobles substation owned by NSP, and a permanent free standing meteorological tower.

The applicant's goal is to achieve commercial operation by October 1, 2012.

Eminent Domain. CWS does not have the power of eminent domain to acquire the land or wind rights for the project. Wind and land rights necessary to build the project must be in the form of voluntary easements or lease agreements between individual landowners and CWS.


