Project Title: County State Aid Highway (CSAH) 17 (Lexington Avenue) Transportation Improvements, Blaine and Ham Lake, Anoka County, Minnesota (SP 02-617-18

Description: In 2012, Anoka County will initiate the reconstruction of CSAH 17 (Lexington Avenue in the cities of Blaine and Ham Lake from CSAH 14 (125th Avenue) to just north of CSAH 116 (Bunker Lake Boulevard). Review and approval of the CSAH 17 Environmental Assessment/Environmental Assessment Worksheet (EA/EAW) was completed by Minnesota Department of Transportation and the Federal Highway Administration in fall 2010. The county encourages the public to attend a Public Hearing and Open House for the proposed Transportation Improvements.



The Open House and Public Hearing will be held Tuesday, December 14, 2010 from 5:30 to 7:00 p.m. (formal public hearing from 6:00 to 6:30 p.m.) at the Blaine City Hall, Cloverleaf Farm Room, 10801 Town Square Drive, Blaine, MN 55449.

The proposed project includes reconstruction of 2.74 miles of an existing rural two-lane roadway to a six- and four-lane divided urban roadway with dedicated left-and right-turn lanes; construction of storm sewer, storm water treatment ponds; construction of an off road bituminous trail; construction of one new traffic signal and the reconstruction of another. This project will impact wetlands and require the acquisition of right-of-way. The tentative schedules for right-of-way acquisition and construction, dependent upon federal approvals, will be discussed at the open house.

The purpose of the open house is to answer questions about the proposed project. Maps, drawings and other pertinent information, including the Environmental Assessment/Environmental Assessment Worksheet

During the public hearing, meeting participants will have the opportunity to submit verbal comments that will become part of the official public hearing record. The hearing will be extended appropriately to accommodate verbal comments.

Project Title: Minneapolis-St. Paul International Airport Expansion Project

Description: The Metropolitan Airports Commission (MAC) is preparing an Environmental Assessment (EA) for proposed development at the Minneapolis-St. Paul International Airport. The proposed development (Proposed Action) includes expanding Terminal 2-Humphrey and relocating all airlines except Delta Airlines and its Skyteam alliance partners to Terminal 2-Humphrey. It also consists of the modernization and expansion of Terminal 1-Lindbergh, including new international arrivals facility.

The MAC's goal is to share information and identify concerns early in the EA process; to that end, you are invited to an Agency Briefing on Tuesday, December 7, 2010. The briefing will be held 10:30am-12:00pm at the MAC's General Offices, located at 6040 28th Ave South, Minneapolis, MN 55450. Although an EA process does not include a scoping period, the MAC is asking for your comments and reaching out in order to assure concerns are addressed adequately in EA. FEIS ADEQUACY DECISION

Project Title: UMore Park Sand and Gravel Resources Project

As the Responsible Government Unit, the University of Minnesota Board of Regents has determined that the Final Environmental Impact Statement (EIS) for the UMore Park Sand and Gravel Resources Project in the City

of Rosemount and Empire Township, Dakota County is adequate. This notice of the Adequacy Determination is being distributed pursuant to Minnesota Rules 4410.2800, subpart 6.

As described in Minnesota Rules 4410.2800, subpart 4, a Final EIS shall be determined adequate if it:

- a. Addresses the potentially significant issues and alternatives raised in scoping so that all significant issues for which information can be reasonably obtained have been analyzed.
- b. Provides responses to the substantive comments received during the Draft EIS review concerning issues raised in scoping; and
- c. Was prepared in compliance with the procedures of the act and parts Minnesota Rules 4410.0200 to 4410.6500.

All conditions specified above have been satisfied. This decision completes the Minnesota environmental review process as found in Minnesota Rules 4410. NOTICE OF PERMIT DECISION

In the Matter of the Application for a Route Permit for the Bemidji – Grand Rapids 230 kV Transmission Line Project

PUC Docket Number: E-017, E-015, ET-6/TL-07-1327

At a meeting on October 28, 2010, and in an Order issued November 5, 2010, the Minnesota Public Utilities Commission determined that the Environmental Impact Statement had adequately addressed the issues identified in the Scoping Decision. The Commission also designated and issued a High Voltage Transmission Line Route Permit to Otter Tail Power Company, Minnesota Power, Minnkota Power Cooperative, Northern States Power, and Great River Energy for the Bemidji – Grand Rapids 230 kV Transmission Line Project, authorizing the Permittees to:

- Construct approximately 70 miles of 230 kV transmission line between the Wilton Substation, located west of Bemidji, and the Boswell Substation, located in Cohasset;
- Modify the Wilton and Boswell substation to accommodate the new 230 kV transmission line;
 and
- Modify and expand the Cass Lake Substation to accommodate the new 230 kV transmission line.

NOTICE OF AVAILABILITY OF ENVIRONMENTAL REPORT

In the Matter of the Application of Prairie Rose Wind, LLC, for a Certificate of Need for an up to 101 MW Large Wind Energy Conversion System in Rock and Pipestone Counties

PLEASE TAKE NOTICE that the Environmental Report (ER) has been completed for the Prairie Rose Wind Large Wind Energy Conversion System (LWECS) and High Voltage Transmission Line (HVTL) proposed for Rock and Pipestone. The ER was prepared for the Certificate of Need (CN) proceeding and addresses potential human and environmental impacts of the proposed project and project alternatives. Project Description

The proposed site is located west of Hardwick and south and east of Jasper in Rock and Pipestone counties. The project is proposed to be constructed in Denver, Rose Dell and Spring Water townships in Rock County and Elmer and Eden townships in Pipestone County. The Project Boundary encompasses approximately 35,335 acres, of which approximately 14,000 acres were under site control at the time of application.

A certificate of need is being requested for an up to 101 MW LWECS, including the following:

- 1. A wind turbine layout consisting of up to 67 turbines, depending on turbine specifications; the application describes the possible use of General Electric 1.5 MW, Vestas 1.8 MW or Siemens 2.3 MW wind turbines:
- 2. Associated facilities, including gravel access roads, an electrical collection system, permanent meteorological towers, one step-up substation, a Sonic (SODAR) or Light (LIDAR) Detection and Ranging unit and an O&M building.

The project has an associated 24-mile 115 kV transmission system that would connect to the Split Rock Substation near Brandon, South Dakota.

The Applicant's goal is to complete the construction of the project and achieve commercial operation between the third calendar quarter of 2011 and the first calendar quarter of 2012.

PUC Review Process

The Project is a "large energy facility" as defined in Minnesota Statute 216B.2421, subp. 2 and a Certificate of Need from the Public Utilities Commission is required for such a project under Minnesota Statute 216B.243. On May 13, 2010, Prairie Rose Wind, LLC, filed a Certificate of Need application for the Project. On July 19, 2010, the PUC issued an Order accepting the application as substantially complete. OES held a public scoping meeting in Jasper on July 27, 2010; and the OES Director released the Scope of the ER on August 23, 2010.

A public hearing on the Certificate of Need will be held shortly after this release of the Environmental Report. Under state law, the PUC proceeding is the only time at which the "no-build" alternative and the size, type, and timing of a new generating facility will be considered. These items will not be addressed in the LWECS or HVTL Permit processes.
