Notice: EQB Releases "Tools to Assist Local Government in Planning for and Regulating Silica Sand Projects," Draft Model Standards and Criteria for Silica Sand Activities

The Minnesota Environmental Quality Board has produced a draft document entitled "Tools to Assist Local Government in Planning for and Regulating Silica Sand Projects."

The document was prepared to fulfill the mandate by the 2013 legislature to prepare model standards and criteria for mining, processing, and transporting silica sand. The document is a toolbox of planning and regulatory approaches that local governments can use to address activities related to silica sand. Silica sand often is called 'frac sand' or 'frack sand'.

Project Title: Draft Environmental Assessment Worksheet (EAW) for TH 34 Passing Lanes from Detroit Lakes to Nevis

Project Description: This project involves constructing improvements to Trunk Highway (TH) 34 at eight locations between Detroit Lakes and Akeley (just east of Nevis) to provide turn lanes and/or passing lanes. The improvements will affect approximately 12 miles of the 57 mile corridor.

Project Title: Blazing Star State Trail, Myre-Big Island State Park to Hayward project

Project Description: Minnesota Department of Natural Resources proposes to extend the Blazing Star State Trail 2.4 miles from Myre-Big Island State Park to Hayward in Freeborn County. The trail will consist of a 10-foot wide bituminous surface for pedestrian, bicycle and other non-motorized uses, and requires a new bridge crossing Albert Lea Lake. The 100-foot single span pedestrian bridge will be adjacent and parallel to the existing railroad bridge.

The Minnesota Department of Natural Resources (DNR) will accept written comments on the Environmental Assessment Worksheet during the public review and comment period, which concludes Wednesday, January 22, 2014, at 4:30 p.m.

PLEASE TAKE NOTICE that the Office of Administrative Hearings will hold a public hearing on behalf of the Minnesota Public Utilities Commission (Commission) on the application of Stoneray Power Partners, LLC to the Commission for a site permit to build and operate a Large Wind Energy Conversion System (LWECS) of up to 105 megawatts (MW) in Pipestone and Murray County.

The purpose of the Draft Site Permit is identify areas of contention. The purpose of the public hearing is to solicit public comments regarding the proposed Stoneray Wind Project and the Draft Site Permit issued by the Minnesota Public Utilities Commission (Commission). Stoneray Wind Power Partners, LLC (Stoneray) is a wholly-owned subsidiary of EDF Renewable Energy (EDF). Representatives from the Public Utilities Commission, the Department of Commerce (EERA) and Stoneray Power Partners will be present to answer questions about the proposed project.

Public Comments. In addition to receiving comments at the public hearing, the Administrative Law Judge (ALJ) will also accept written comments now until 4:30 p.m., Tuesday, January 28, 2014. Proposed Site Location. The proposed Stoneray Wind Project is located in Pipestone and Murray Counties in the townships of Rock, Burke, Chanarambie and Cameron, around the community of Woodstock. The site encompasses 29,500 acres.

Project Description. Stoneray proposes to install between 32 and 62 wind turbine generators depending on what turbines are ultimately selected. Turbines under consideration are the General Electric 1.7-100, Vestas V110-2.0, Siemens SWT-2.3-108, and Siemens SWT-3.2-113. Hub heights range from 80 to 100 meters. Associated facilities include transmission lines, a project substation, collection and feeder lines, turbine access roads, temporary and permanent meteorological towers, and an O&M facility. Stoneray proposes is to achieve commercial operation by December 31, 2014.

Commission Review Process. The Commission is reviewing this project under the Wind Siting Act (Minnesota Statutes chapter 216F) and the Wind Permitting Rules (Minnesota Rules chapter 7854).

Stoneray filed a site permit application for the 105 MW LWECS with the Commission on June 11, 2013. The Commission issued an order accepting the site permit application on July 24, 2013.

The Department of Commerce Energy Environmental Review and Analysis (EERA) staff solicited comments on issues to be considered in developing a Draft Site Permit for this project until August 30, 2013. EERA staff has prepared a Draft Site Permit for consideration by the Commission. On December 19, 2013, the Commission met and verbally approved the Draft Site Permit for distribution and public comment, the draft site permit is available in eDockets. Under the LWECS siting process, environmental review is incorporated into the development of the site permit application and the site permit itself; there is no separate environmental review document prepared on the project.

Judge Cochran will use information gathered at the public hearing and during the comment period to write a report for the Commission. The report will include findings, conclusions, and recommendations about this site proposed for this project and will include a summary of the public comments provided at the hearing. After receiving the Judge's report, the Commission will make final decisions on this project at a separate meeting, expected by June 2014.

Contested Case Hearing Request. Any person may request a contested case hearing on the site permit proceeding for the Stoneray Wind Project pursuant to Minnesota Rules 7854.0900. All requests for a contested case hearing must be filed in writing with the ALJ by 4:30 p.m., January 28, 2014. The person requesting the contested case hearing must list the issues sought to be addressed in the hearing and the reason why a contested

case hearing is required to resolve those issues. The Commission shall order a contested case hearing if it finds that a material issue of fact has been raised and that a contested case hearing will aid the Commission in making a final decision on whether to authorize construction of the project.

NOTICE IS HEREBY GIVEN that the Minnesota Public Utilities Commission held the annual public hearing on the Power Plant Siting and Transmission Line Routing Program at 1:00 p.m. on Wednesday, December 18, 2013, in the Large Hearing Room at the Commission's offices, 121 7th Place East, Suite 350, St. Paul, Minnesota, 55101. Administrative Law Judge Ann O'Reilly presided.

The annual hearing is required by Minnesota Statute § 216E.07, which provides that:

The commission shall hold an annual public hearing at a time and place prescribed by rule in order to afford interested persons an opportunity to be heard regarding any matters relating to the siting of large electric generating power plants and routing of high-voltage transmission lines. At the meeting, the commission shall advise the public of the permits issued by the commission in the past year.

While the Commission grants permits for many different types of energy facilities, this hearing focused on the process for siting large electric power plants and the routing of high-voltage transmission lines. Comments made in this proceeding will not be part of the record in any other Commission docket. If you have comments as to a specific project that is now under review, please be sure to submit those items during the comment period for that docket.
