### **Project Title: Granite Falls Energy, LLC – Ethanol Plant Expansion Project**

**Description:** Granite Falls Energy, LLC (GFE), is an existing fuel-ethanol production facility (Facility) located in Granite Falls, Minnesota GFE proposes to expand its permitted undenatured ethanol production capacity from 49.9 million gallons per year (MMGY) to 70 MMGY. The expansion would be achieved by adding additional equipment to support ethanol production. This additional production equipment will be located within GFE's current property boundary. The primary source of fuel for the Facility is natural gas (propane can be used as a backup).



In addition to the EAW, the MPCA's draft Air Emissions Permit and draft National Pollutant Discharge Elimination System/State Disposal System (NPDES/SDS) Permit for the GFE Expansion Project will also be on public notice concurrently. The contact person for the draft Air Emissions Permit is Jim Robin (651-757-2739). The contact person for the draft NPDES/SDS Permit is Kate Frantz (651-757-2370).

The Minnesota Pollution Control Agency will host a public informational meeting on the EAW and permits. The meeting will be held on January 10, 2011, at 7:00 p.m., at the Minnesota West Community Technical College in Granite Falls. MPCA staff will also be available one hour prior to the meeting to answer questions in an open house format.

**Description:** Strata Corporation is proposing to construct a granite quarry operation south of Ortonville in Ortonville Township, Big Stone County, MN. The project involves the development of a new granite aggregate mining and processing operation on a 95.55 acre quarry site plus related ancillary operations and features. Construction activities are planned to begin in 2011 with the site becoming fully operational in 2012.

#### Project Title: Interstate 494 (I-394 to East Fish Lake Road) Expansion Project EA/EAW (S.P.2785-330)

#### **Description:**

The proposed project will construct a new travel lane on the inside shoulder of north- and southbound I-494 from I-394 to the East Fish Lake Road overpass in the Cities of Minnetonka, Plymouth, and Maple Grove. Auxiliary lane improvements will also be constructed in the southbound direction at the I-494 interchange with I-394. Existing I-494 bridges over the Canadian Pacific Railway will be redecked and widened. Existing I-494 bridges at Schmidt Lake Road and CSAH 47 will be either replaced or redecked and widened. The southbound I-494 bridge at I-394 will require widening on the right shoulder. The project also includes construction of stormwater ponds and noise barriers. All construction activity is anticipated to take place within existing I-494 right of way.

#### NOTICE OF INTENT TO HOLD STATE METALLIC MINERALS LEASE SALE

#### State Lands to be Offered for Metallic Minerals Exploration

The Minnesota Department of Natural Resources announces that plans are being developed to hold the state's 32nd sale of metallic minerals exploration and mining leases. The sale is tentatively scheduled for April 2011. The lease sale plans are being announced at this time in order to give mining companies, public interest groups and all other interested parties additional time to review the areas under consideration.

The purpose of Minnesota's metallic minerals rules (Minnesota Rules, parts 6125.0100 - .0700) is to promote and regulate the exploration for, mining and removal of metallic minerals on stateowned and state-administered lands. These rules, and the leases issued under these rules, authorize exploration and development of these minerals and impose certain requirements on the lessee. The requirements include: the payment of rentals that increase with the passage of time, the payment of royalty for all ore mined and removed, the submission of data and other reports, and the addressing of environmental considerations. In addition, the state lessee must comply with all applicable regulatory laws.

The areas under consideration for the lease sale cover portions of Itasca, Koochiching, Lake and Saint Louis Counties. Some of the lands being considered have been offered in previous metallic minerals lease sales, but based upon the interest shown by industry, new geologic data, and exploration techniques developed during the past few years, it is felt that within these lands there is significant potential for the discovery of mineral resources. Certain new lands of interest are also being considered for the lease sale.

The exact time and place of the lease sale will be announced by legal notice at least thirty (30) days prior to the sale. Mining unit books, listing the state lands to be offered at the lease sale, will be available for inspection or purchase at that time.

**PLEASE TAKE NOTICE** that a public hearing will be held on behalf of the Minnesota Public Utilities Commission (Commission) on the application of Prairie Rose Wind, LLC (Applicant), for a Certificate of Need, in conjunction with a public meeting on the draft for a Site Permit for the proposed Prairie Rose Wind Farm (Project). The hearing and public meeting will address respectively: (1) whether the proposed Project is needed and in the public interest, and (2) issues related to the proposed siting of the Project. The hearing will be held at the time and location listed below. Ending times reflect the latest a public hearing will run. The hearing may conclude earlier if all attendees have had the opportunity to comment and all other business has been concluded

Administrative Law Judge. Administrative Law Judge (ALJ) Richard Luis from the Minnesota Office of Administrative Hearings will preside at the hearing. Any person who would like to comment on the need for the Project or the proposed siting can do so at the hearing or in writing to Judge Luis: Richard Luis, Office of Administrative Hearings, P.O. **Written Comments.** Written comments on the Certificate of Need or the Draft Permit should be submitted to Judge Luis at the address listed above. Comments will be accepted through January 27, 2011. Mailed comments must be postmarked by this date. Faxed and delivered comments must be received by 4:30 p.m. on this date.

**Purpose and Conduct of the Hearing.** The purpose of the public hearing is to receive input about the Project. During the public hearing, members of the public may offer either oral or written testimony, offer exhibits for inclusion in the public hearing record and ask questions of the applicant and agency representatives. Any

person who wishes to ask questions, but does not want to ask the questions personally, may submit them in writing to the ALJ who will then ask the question during the hearing.

Interested persons may comment on the Certificate of Need and Site Permit Applications, Environmental Report, Draft Site Permit or on the Project generally. The hearing will continue until all persons have had the opportunity to offer testimony and ask questions. If needed, the hearing may be recessed and continued by the ALJ. At the close of the written comment period Judge Luis will prepare a written summary of the comments received at the hearing and file it with the Commission, which will consider them in its deliberations of the certificate of need and site permit applications.

**Environmental Report.** The Office of Energy Security, Energy Facility Permitting, has completed and issued an environmental report for the proposed Prairie Rose Wind Farm. The environmental report addresses potential human and environmental impacts of the proposed project and alternatives. For a copy of the environmental report, please see project contacts and information below.

**Draft Site Permit.** On October 28 2010, the Commission issued an order approving a draft site permit for distribution and public comment. For a copy of the draft site permit, please see project contacts and information below.

**Project Description.** The Applicant proposes a Large Wind Energy Conversion System (LWECS) of 101 megawatts (MW). Depending on which turbines are selected, the wind turbine layout will consist of up to 67 turbines. If General Electric (GE) 1.5 MW wind turbines are selected, the hub height will be 80 meters (263 feet) and the rotor diameter will be 77 meters (252 feet). If Vestas 1.8 MW wind turbines are selected, the hub height will be 80 meters (263 feet) and the rotor diameter will be 77 meters (252 feet). If Vestas 1.8 MW wind turbines are selected, the hub height will be 80 meters (263 feet) and the rotor diameter will be 90 meters (295 feet). If Siemens 2.3 MW wind turbines are selected, the hub height will be 80 meters (331 feet). In addition to the wind turbines, the Project would include access roads, a meteorological tower, a Sonic Detection and Ranging unit or Light Detection and Ranging unit, an electrical collection system, project substation, a metering yard, transmission line and an operations and maintenance building. Power will ultimately be delivered to the Prairie Rose substation located in Rose Dell or Denver Township, where it will be converted to 115 kV and will then be transported via a new 115 kV line to the Split Rock substation near Brandon, South Dakota.

The Project area (shown in the accompanying map) consists of approximately 35,335 acres located in Denver, Rose Dell and Springwater Townships in Rock County and Elmer and Eden Townships in Pipestone County. The Applicant has acquired easements, or made lease agreements, for the Project on approximately 23,145 acres in the Townships.

**Eminent Domain.** The Applicant does not have the power of eminent domain to acquire the land or wind rights for the project. Wind and land rights necessary to build the facility must be in the form of voluntary easements or lease agreements between individual landowners and the applicant.

Authority and Statement of Issues to be Decided. In order to proceed with this Project, the Applicant must obtain a certificate of need and a site permit from the Commission. The Commission is authorized by Minnesota Statutes section 216B.243, to issue a certificate of need for a large wind energy facility if the applicant can demonstrate that there is a need for the Project. A certificate of need is a state permit that is issued upon a determination that construction of an energy facility is in the public interest. The Commission is required by Minnesota Statutes section 216B.243, subdivision 4, to hold a hearing on the application for a certificate of need.

The Commission is authorized by Minnesota Statutes section 216F.04 to issue LWECS site permits for certain wind energy facilities. When the Commission designates a site, it issues a site permit for the construction of a facility specifying the design, location, preparation, and operation of the facility, along with any other appropriate conditions it deems necessary. The Commission is required by Minnesota Statutes section 216F.05 and Minnesota Rule 7854.0900 to hold a public meeting on an application for a site permit for an LWECS.

**Contested Case Hearing Request.** Any person may request a more formal contested case hearing on the site permit proceeding for the LWECS pursuant to Minnesota Rule 7854.0900. All contested case hearing requests must be filed with Judge Luis in writing by 4:30 p.m. on January 27, 2011. The person requesting the contested case hearing must list the issues sought to be addressed in the hearing and the reason that a contested case hearing is required to resolve those issues. The Commission shall order a contested case hearing if it finds that a material issue of fact has been raised and that the holding of the contested case hearing will aid it in making a final decision on whether or not to authorize construction of the Project.
