#### Project Title: Highway 52 at CSAH 24 in Cannon Falls (S.P. 2056-52)

**Description:** Mn/DOT, along with the City of Cannon Falls, Goodhue County, adjoining townships, and the FHWA are working in partnership to address mobility, safety, and connectivity concerns along Trunk Highway (TH) 52 in the City of Cannon Falls. The proposed project includes replacing the two existing traffic signals at TH 52 in Cannon Falls with an interchange of CSAH 24 and TH 52. The interchange would be at the approximate location of 324<sup>th</sup> Street with an overpass at existing North CSAH 24 (315<sup>th</sup> Street). The final location or inclusion of this overpass will be dependent upon the findings of a Phase II Environmental Site Assessment, which will determine the extent of contamination at the intersection of TH 52 and north CSAH 24 (315<sup>th</sup> Street) and Highview Road are also included in the project concept. The project is not funded for construction at this time. The EA/EAW process is being done at this time to help guide local land use and transportation planning and to allow for improvement projects, consistent with the design concept, to be implemented as funding becomes available.

### **FEDERAL EIS NEED DECISION - FONSI**

#### Project Title: Minnesota Project BRNH-TCSP 09MN (003) –TH 61 Hasting Bridge Project

The Federal Highway Administration (FHWA) has determined that proposed replacement of the Hastings Bridge and associated roadway improvements, as described in the Environmental Assessment (EA), will have no significant impact on the human environment, and that preparation of an Environmental Impact Statement EIS is not required. This Finding of No Significant Impact (FONSI) is based on an EA that has been determined to adequately and accurately discuss the need, environmental issues, and impacts of the proposed project and appropriate mitigation measures.

### NOTICE OF DRAFT ENVIRONMENTAL IMPACT STATEMENT (DEIS) AVAILABLITY

#### **Project Title: UNIMIN Minnesota Corporation North Mine**

**Description:** The Le Sueur County Board of Commissioners announces that a Draft Environmental Impact Statement (DEIS) completed for a proposed expansion of the UNIMIN Minnesota Corporation silica sand mining operation consisting of approximately 1015.5-acres is available for public comment. Property is located in Section 15, 21, 22, 23, and 27 of Ottawa Township, Le Sueur County, Minnesota.

The project is nonmetallic mineral mining of a 1,015.5-acre site in an area where mining has occurred for 80 years. The mining involves excavation of overburden to expose sandstone that is blasted, placed in slurry form, and pumped to an existing processing plant. Reclamation will be ongoing as mining is conducted. The UNIMIN Minnesota Corporation, with offices located in Le Sueur County, Minnesota is the proposer of the project.

### AUAR UPDATE AVAILABLE

#### Project Title: Cedar Grove Redevelopment Area AUAR Update

On December 15, 2009, the City of Egan Council approved for distribution the Cedar Grove Redevelopment Area AUAR Update. This document updates the Final AUAR and Mitigation Plan adopted November 7, 2002. Update of the AUAR is required by Minnesota Rules 4410.3610, Subpart 7(A) if five years have passed since the Responsible Governmental Unit (RGU) adopted the original environmental analysis document and plan for mitigation.

The AUAR Update is distributed in accordance with Minnesota Rules 4410.3610, Subpart5 (D-H) and Subpart 7. State agencies and the Metropolitan Council of the Twin Cities have ten days from the date of receipt of the AUAR Update to file an objection to the document with the City of Eagan, the RGU. Persons not entitled to object to the document may submit comments to the RGU suggesting changes within the same ten day time limit. ### **ROTENONE APPLICATION PLANNED by the DEPARTMENT OF NATURAL RESOURCES FISH and WILDLIFE DIVISION**

The DNR Division of Fish & Wildlife is planning rotenone treatments of the County Ditch 86 and any tributaries, entering Courtland Bay on Swan Lake (DOW# 52-34) in Nicollet County, in Brighton Township (110N, range 29W, multiple sections). County Ditch 90 and its tributaries in the same township and range may also be treated.

This project will include the application of 2.5% synergized liquid rotenone, a federally and state registered pesticide to control carp. The chemical application will occur in sometime between January 2010 and March 2010. Rotenone distribution will be done by tank or backpack sprayer and by drip. Target treatment concentration will be 3-6 ppm of 2.5% liquid rotenone or a similar concentration of powdered rotenone, or a combination of liquid and powder. Smaller wetlands, ditches or drain tile outlets connected to the above ditch maybe treated if necessary.

Endangered or threatened species are not known to be present in these drainage ditches. Project goal is to remove the undesirable fish species, carp, in order to prevent invasion into Swan Lake, an important wildlife habitat lake in southern Minnesota.
