Project Title: Kohl's Duluth Parking Replacement Project

Description: A Minnesota Department of Transportation realignment project for Miller Trunk Highway 53 resulted in a substantial loss of parking stalls for Kohl's Department Store in Duluth. To mitigate the loss of stalls and to provide adequate infrastructure for the store, Kohl's proposes to build a parking replacement area adjacent to the existing parking lot. The project will impact 18,891 sq. ft. of floodplain forest and shrub-carr wetlands. Mitigation is proposed to satisfy Wetland Conservation Act and US Army Corps of Engineers standards.

Project Title: Lake Olaf Drawdown

Description: Lake Olaf is located in the northwestern part of Otter Tail County. The water level in Lake Olaf has consistently increased since 1999 and currently threatens the submergence of CSAH 30. As such, the Project proposes to draw down Lake Olaf through mechanical means and open channels and discharge to the Pelican River.

The project area is located just west of Pelican Rapids, MN, within Norwegian Grove and Pelican Townships.

Project Title: Rush Creek Habitat Restoration Project

Description: The Minnesota Department of Natural Resources (MDNR) proposes to remove a failed low-head dam in Rush City, Chisago County, Minnesota and to restore and stabilize a portion of Rush Creek upstream of the dam. The proposed stream channel restoration is a natural channel design that is achieved by adjusting the dimension, pattern, and profile for 2,830 feet of stream to improve stream stability and fish habitat. Off-channel ponds will also be created in the project area to provide benefits for wildlife and recreation.

The MDNR will accept written comments on the Environmental Assessment Worksheet during the public review and comment period, which concludes Wednesday, March 11, 2009 at 4:30 p.m.

Project Description

The proposed HVTL would be an 115 kilovolt (kV) alternating current transmission line with two new substations. The permit application is for the construction, operation, and maintenance of a new 115 kV transmission line circuit approximately eight miles in length, connecting a new substation in Rapidan Township to a new substation in Mankato Township, through to the existing Pohl Road Substation. The proposed facilities also would include substation and equipment upgrades at the Wilmarth and Eastwood substations to accommodate the upgraded transmission facilities.

Applicants have proposed to 1) construct a new South Bend 115-161/69 kV substation and rebuild an existing 69 kV transmission line to 115 kV to the Ballard Corner Switches on 200th Street; 2) construct a new Stoney Creek 115/69 kV substation and rebuild an existing 69 kV transmission line to a 115/69 kV double circuit transmission line from the Ballard Corner Switches to the proposed Stoney Creek Substation; and 3) rebuild the existing 69 kV transmission line to 115 kV from the proposed Stoney Creek Substation to the existing Pohl Road Substation.

PUC Review Process

Xcel Energy and Great River Energy have submitted an Application for a Route Permit to the Public Utilities Commission. OES was assigned to hold a public meeting and prepare an environmental assessment of the proposed transmission lines under the alternative review process found in Minn. Rule 7849.5510-5720. OES has prepared the EA, analyzing the environmental impacts and alternatives to the proposed transmission route.

A Public Hearing presided over by an Administrative Law Judge from the Office of Administrative Hearings will be held in Mankato in February, 2009. Notice of the hearing will be published in local newspapers and mailed by U.S. Mail to persons receiving this notice.
