### **Project Title: Loch Haven**

**Description:** Loch Haven is a proposed 61 unit residential common interest development bordering Spot Lake in Cass County, located on 20<sup>th</sup> Street SW, McKinley Township, one-quarter mile west of Minnesota Trunk Highway No. 64. The development is on 113 acres. It will have equestrian amenities, and be serviced by private wells and clustered sewage treatment systems.

**PLEASE TAKE NOTICE** that a public hearing will be held on behalf of the Minnesota Public Utilities Commission (Commission) on the Xcel Energy route permit application for the CapX2020 Hampton-Rochester-La Crosse 345 kV and 161 kV transmission line project. The Minnesota Department of Commerce has prepared a draft environmental impact statement for the project. The Minnesota Office of Administrative Hearings will hold public hearings at the times and locations noted below. Ending times reflect the latest a public hearing will run. Hearings may conclude earlier where all attendees have had the opportunity to comment and all other business has been concluded.

### PUBLIC HEARING DATES AND LOCATIONS

Hearings will be held from **1:30** – **4:30 p.m. and 6:30** – **9:30 p.m.** at each venue. Each hearing will offer the same information and opportunity to comment, so interested persons need attend only one of the hearings

The evidentiary hearing will convene on June 20, 2011, at the Public Utilities Commission in Saint Paul, and will continue through June 24, 2011, as necessary to complete the hearing.

**Public Hearing.** The purpose of the public hearing is to receive comments from members of the public and to compile the record for the Commission to consider in making a final decision on the transmission line route permit request. The Administrative Law Judge will write a report and make a recommendation to the Commission on which route to authorize and on any appropriate permit conditions. The Commission will make a final decision on the route permit at a subsequent Commission meeting.

Written Comments. Written comments regarding the route permit should be submitted directly to Judge Sheehy. Comments may be submitted by U.S. Mail, fax or email. Comments will be accepted through June **30, 2011**, and should include the Office of Administrative Hearings (OAH) Docket Number 3-2500-21181-2. Mailed comments must be postmarked by that date. Emails should be sent to <u>routecomments.oah@state.mn.us</u>. Faxed, emailed, and delivered comments must be received by 4:30 p.m. on that date.

**Office of Administrative Hearing Rules.** The ALJ will conduct the contested case hearings in accordance with Minnesota Statutes, Chapter 14, and the Office of Administrative Hearings procedural rules for the Commission's energy facility permitting process (Minnesota Rules, Chapter 1405). The applicable statutes and rules are available on the Office of the Revisor of Statutes webpage at: <u>https://www.revisor.mn.gov</u>. Statutes and rules may also be purchased at Minnesota's Bookstore, 660 Olive St., St. Paul, Minn. 55155, or telephone at (651) 297-3000.

**Conduct of Hearing.** At the start of each hearing session, the ALJ will explain the procedural rules for the hearing, including the sequence for providing testimony and questioning witnesses. Members of the public may participate without the necessity of intervening as a party. Representation by legal counsel is permitted but not required. Participation includes: a) offering direct testimony; b) offering testimony or other material in written form at or following the hearing; and c) questioning witnesses.

Any person who wishes to question a witness, but does not want to ask the questions, may submit questions in writing to the ALJ, who will then question the witness. Questions may be submitted during the hearing or may be sent to the ALJ in advance of the hearing. Upon completion of the hearings, a transcript of the proceedings will be available at local libraries.

**Continuation of Hearing.** The ALJ may elect to recess the hearing and set additional days for hearing, if necessary.

**Request for Accommodation.** Any person who needs an accommodation for a disability in order to participate in the hearing, and any person who requires an interpreter, including a foreign language interpreter, should promptly notify the Office of Administrative Hearings, P.O. **Route Permit.** Under the Power Plant Siting Act (Minn. Statute 216E.03, subd. 2), a route permit from the Commission is required to build a high-voltage transmission line. A high-voltage transmission line is a conductor of electric energy and associated facilities designed for and capable of operation at a nominal voltage of 100 kilovolts (kV) or more and is greater than 1,500 feet in length. A route permit application for the proposed 345 kV and 161 kV transmission line project was filed by the applicant on January 19, 2010, and was accepted as complete by the Commission on March 9, 2010. Department of Commerce, Energy Facility Permitting (EFP) staff prepared a draft environmental impact statement (EIS) on the proposed project. The draft EIS discusses potential impacts of the project, evaluates alternatives, and suggests mitigation. **Project Description.** Xcel Energy, on behalf of itself and regional utilities that are part of the CapX2020 initiative, is proposing to construct and operate a new 345 kV high voltage transmission line (HVTL), approximately 90 miles in length in Minnesota, connecting an existing substation near Hampton, Minn., to a proposed North Rochester Substation between Zumbrota and Pine Island, Minn., and continuing eastward to cross the Mississippi River near Kellogg, Minn. The line would continue in Wisconsin an additional 50 miles to a new substation in the La Crosse, Wis., area. In addition, the project includes a new 161 kV line, approximately 15 miles in length, between the proposed North Rochester Substation and the existing Northern Hills Substation in northwest Rochester.

The proposed 345 kV transmission line would be constructed primarily with single-pole steel structures, ranging in height from 130 to 175 feet, with an average span of 1,000 feet between poles. The structures would be "double circuit capable," meaning that a second 345 kV circuit could be placed on the structures in the future if warranted. The typical right-of-way (ROW) for the 345 kV transmission line would be 150 feet.

The proposed 161 kV transmission line would be constructed primarily with single-pole steel structures, ranging in height from 70 to 105 feet, with an average span of 400 to 700 feet between poles. The typical ROW for the 161 kV transmission line would be 80 feet.

The proposed project includes construction of a new substation, in an area between Zumbrota and Pine Island, Minnesota, and modifications at two existing substations. The new "North Rochester Substation" would require the acquisition and development of 40 acres for substation infrastructure. Project construction is expected to begin in the second quarter of 2012 and be completed and in service by the fourth quarter of 2015.
