The Draft EAW identifies the preferred alternative alignments which connect the existing Pierce Butler Route east of Dale Street to Phalen Boulevard at 35-E.

Project Title: Trunk Highway 10 in Ramsey Preliminary Interchange Design

**Description:** The project involves the conversion of Trunk Highway 10 from an expressway to a freeway between 3,000 feet west of Ramsey Boulevard (County State Aid Highway 56) and the eastern Ramsey city limits. As of this time, project funding has not been identified. Right of way acquisition, construction and other project implementation activities will occur as funds are available.

Proposed LeSauk and Sartell 115 kV transmission lines, proposed 115 kV conversion of the LeSauk distribution substation and proposed new Sartell 115 kV distribution substation

#### PUC Docket Number ET2/LR-09-412

**Description:** Great River Energy (GRE) is proposing to increase the voltage capacity of the existing LeSauk distribution substation and rebuild approximately 0.4 miles of existing 69 kV transmission line to 115 kV. This will relieve electric loading issues on the West St. Cloud Substation and relieve low voltage problems in the surrounding electric transmission system.

GRE will also construct approximately two miles of new 115 kV transmission line to serve a new distribution substation that will be constructed by Stearns Electric Association. The new substation will serve the electric load created by present and future residential and commercial growth in the City of Sartell and surrounding areas. As part of the project, an existing SEA three-phase distribution line located along Stearns County Road 133 will be buried.
