

Project Title: Viracon Campus Additions

Project Description: Viracon, Inc. is proposing construction of seven building additions at the existing campus located at 300 Park Drive in Owatonna, Minnesota, to allow for increased efficiency and expanded storage capacity of architectural glass products. The square footage of the proposed additions totals 538,019 square feet, with construction occurring in multiple phases over a 4-year period (2016-2020).
