Project Title: 600 Washington Avenue SE

Project Description: The 600 Washington Avenue SE project is a proposed 27-story, multiuse, transit-oriented development (TOD) located along the METRO Green Line LRT in Minneapolis. The project consists of a multi-family residential building with up to 450 residential units, approximately 12,500 square feet of commercial space on the ground floor and up to 201 enclosed parking spaces.

Copies of the EAW will be available for review at the downtown Minneapolis Central Library located at 300 Nicollet Mall, and in the office of the City's CPED, Land Use, Design and Preservation Section at 250 S. 4th Street, Room 300 Public Service Center. Notice will be published in the EQB Monitor on Monday, April 4th, 2016. Public comments on the EAW must be made within the 30-day comment period, which ends at 4:30 p.m. on Wednesday, May 4th, 2016. It is anticipated that the Zoning and Planning Committee at its regular meeting on May 19th, 2016, or at a subsequent meeting, will receive a report and recommendation from City staff, hear comment from all parties and consider the adequacy of this EAW and the need for an Environmental Impact Statement for this proposal. The City Council will act on the recommendation of this Committee at a subsequent meeting on May 27th, 2016.

The Environmental Quality Board Seeks Public Comment on a Request for a Different Responsible Governmental Unit

On March 10, 2016, the Environmental Quality Board ("EQB" or "Board") received a citizen request for a different responsible governmental unit ("RGU") for the environmental review of the North Dakota Pipeline Company LLC's proposed Sandpiper Pipeline and Enbridge Energy, Limited Partnership's proposed Line 3 Replacement Pipeline projects. More specifically, the citizen requests that the EQB relieve the Minnesota Public Utilities Commission ("Commission") of its current RGU status for the above-entitled projects and replace it with a joint RGU consisting of the Minnesota Pollution Control Agency ("PCA") and the Minnesota Department of Natural Resources ("DNR").

At this time EQB is gathering additional information on the merits of the request to designate a different RGU for the proposed projects. Consequently, the EQB is providing a 30-day comment period, starting on Friday, April 1, 2016 through 4:30 pm on Monday, May 2, for additional information relevant to Minnesota Rules 4410.0500 and whether to designate a different RGU for the proposed Sandpiper Pipeline and the proposed Line 3 Replacement Pipeline.

Board meetings are held in the lower level Board Room at the PCA office building located at 520 Lafayette Road North, Saint Paul, MN 55155.

The EQB will present a Findings of Fact, Conclusions and Order which will come before the Minnesota Environmental Quality Board at its regular meeting on May 18, 2016.
