Project Title: L&H Station

Project Description: The proposed L&H Station project would result in the redevelopment of an approximate six and one half-acre site adjacent to the LRT Station at Hiawatha and Lake Street in Minneapolis. This phased development is anticipated to be developed in four separate phases over ten years, and would provide at completion a total of 565 residential units, a 100,000 square foot office building, 16,075 square feet of commercial space, 840 off-street parking spaces and a public plaza/marketplace.

Project Title: Flint Hills Resources – Tier 3 Clean Fuels Projects

Project Description: The Tier 3 Clean Fuels Projects involve refinery changes to meet the requirements of the U. S. Environmental Protection Agency (EPA) Tier 3 gasoline sulfur standard, which targets improvements in ambient air quality. In order to produce gasoline meeting the Tier 3 standard, Flint Hills Resources (FHR) must remove and recover more sulfur from fuel blends, increasing hydrotreating (a process that removes sulfur). FHR also proposes to install a process to convert recovered gas containing sulfur and nitrogen into a salable aqueous liquid fertilizer, Ammonium Thiosulfate (ATS). Additionally, FHR is proposing to improve the refinery's sour water skimming and storage and switch to a more efficient amine solution in the existing amine units (for sulfur recovery).

Project Title: US Highway 53 Virginia to Eveleth

Project Description: This Draft EIS describes the transportation and environmental impacts associated with the pending termination of easement rights for a one and a half mile segment of the US 53 corridor where it crosses the United Taconite open-pit mine between Virginia and

Eveleth, Minnesota. Five potential alignments were evaluated in the Draft EIS: No Build Alternative, Existing US 53 Alternative, Alternative M-1, Alternative E-1A, and Alternative E-2.

Documentation regarding Section 4(f) recreational resource impacts is also included in the Draft EIS. The Federal Highway Administration intends to make a de minimis impact determination for the Iron Range Off-Highway Vehicle Recreation Area.

Draft Order for Review: As the Responsible Governmental Unit (RGU), the City of St. Michael is issuing this draft order for an Alternative Urban Areawide Review (AUAR) process on 78 acres of privately-owned land situated in the southeastern portion of the City of St. Michael, Wright County, Minnesota. This order specifies the boundaries of the geographic area and the anticipated nature, location, and intensity of development and associated infrastructure within those boundaries.

This draft AUAR order is issued to initiate scoping, which is required under Minnesota Rules 4410.3610, Subp. 5a because a specific development project proposed in the AUAR area exceeds the EIS threshold set forth at Minnesota Rules 4410.4400, Subp. 14a, and because that specific project covers at least 50 percent of the AUAR area.

Project Description: The AUAR area is bordered on the east by Labeaux Ave. NE (CSAH 19) and residential development, on the north and south by agricultural land and residential development, and on the west by Gonz Lake. The AUAR area includes one parcel of land (PID 114-500-231100) located at 2381 Labeaux Ave NE, within the south ½ of Section 23, T120N, R24W.

Project Title: Anoka County State Aid Highway 14/125th Avenue NE Reconstruction Project

Project Description: The County State Aid Highway 14/125th Avenue NE Reconstruction Project is approximately 1.5 miles long and extends from Radisson Road (County Road 52) to just east of Harpers Street NE in the City of Blaine, Anoka County. The project proposes to reconstruct the highway as a four-lane divided section with left and right turn lanes at key intersections. New traffic signals are proposed at Cloud Drive and Harpers Street. Minor improvements are included along Harpers Street between 125th Avenue NE/CSAH 14 and 126th Avenue NE. The improvements also include the construction of multi-use trails and sidewalks.

Transgenic potato with low acrylamide potential and reduced black spot bruise - Commercial Use Exemption

Simplot Plant Sciences (J.R. Simplot Company) has requested an exemption from the Minnesota Department of Agriculture's Genetically Engineered Organism Release Permit for potato events designated as InnateTM potatoes (events E12, E24, F10, F37, J3, J55, J78, G11, H37, and H50). These genetic modifications result in potato lines with low acrylamide potential and reduced black spot bruise. A determination of non-regulated status has been issued by USDA.
