

Project Title: Rochester Public Utilities - Westside Energy Station

Project Description: Rochester Public Utilities ("Proposer") proposes to construct a new generating station ("Project") next to their Westside substation in Cascade Township, Olmsted County, Minnesota. The Project includes installation of five (5) new natural gas fired reciprocating engines for a total generating capacity of 48 megawatts ("MW"). Power generated by the Project help serve the Proposer's customers and backup intermittent resources such as wind and solar power generation during peak demand periods.

Project Title: Bemidji Upper Elementary School

Project Description: Bemidji Public Schools proposes to construct a new 120,000 square foot elementary school and associated facilities to support the growth in student enrollment and alleviate overcrowding issues in existing facilities. The new school will also reduce classroom sizes and improve learning environments in the district.

Project Title: R & R Hogs LLC

Project Description: R & R Hogs LLC ("Proposer") proposes to construct a new swine finishing feedlot in Section 4 of Dunbar Township, Faribault County ("Project"). The Proposer will construct two 102-feet x 160-foot total confinement, power ventilated buildings with eightfoot deep reinforced, poured-in-place concrete liquid manure storage pits below the buildings

and a separate mortality composting building. The Project will house up to a total of 4,000 finishing hogs or 1,200 animal units in the two buildings.

Environmental Impact Statement Need Decision

The following petition has been filed with the EQB requesting preparation of an Environmental Assessment Worksheet (EAW). The EQB has assigned the indicated unit of government to review the petition and decide on the need for an EAW.

Mora Airport Primary and Crosswind Runway Environmental Assessment (EA) Written Reevaluation

A written re-evaluation was determined to be necessary for the 2004 Primary Runway and

Crosswind Runway Environmental Assessment (EA) and Finding of No Significant Impact (FONSI) for Mora Municipal Airport per Federal Aviation Administration (FAA) Order 1050.1F, Environmental Impacts: Policies and Procedures, Paragraph 9-2 and FAA Order 5050.4B National Environmental Policy Act, Chapter 1401 C (3). After further investigation, new information revealed that additional resource impacts beyond what was identified in the 2004 EA/FONSI would occur due to the project, thereby necessitating a re-evaluation of the EA.

The EA re-evaluation addresses undisclosed resource impacts that were not covered in the original 2004 EA/FONSI. Additional proposed environmental impacts are a result of further design changes and new endangered species listings since the 2004 EA/FONSI. Resource categories where a change may occur include the following:

- Utilizing the construction limits; there is proposed to be a conversion of wetland types and additional wetland fill. The original 2004 EA unintentionally omitted this affected resource.
- 2. The butternut tree was not studied in the original 2004 EA. Since signing of the FONSI, the butternut tree was listed as endangered by the State of Minnesota.
- 3. The Northern Long Eared Bat (NLEB) and Grey Wolf were not analyzed in the original 2004 EA. Since FONSI signature, the NLEB and Grey Wolf were listed as threatened under the Endangered Species Act (ESA).
- 4. Filling and excavating of upland farmland.

Through analysis of new project impacts to environmental resources and comparing these impacts to what was originally identified in the original EA/FONSI, it was concluded that a new EA or supplemental EA is not warranted. Overall project impacts are minor in scope. The additional wetlands filled are permittable with the appropriate level of mitigation. Impacts to butternut trees were also permitted. The U.S. Fish and Wildlife Services was consulted with under Section 7 of the Endangered Species Act in which the USFWS concurred with the FAA's finding. The FAA provided updated project information to the State Historic Preservation Office (SHPO) and the SHPO concurred that the original determination of No Historic Properties Affected is still valid. The purpose and need and alternatives were substantiated. All of these impacts and analyses still fall within the general overall context of the original EA/FONSI.
