Project Title: Strobel Farms - Alton 30 Site

Project Description: Strobel Farms ("Proposer") proposes to construct and operate two (2) new total confinement swine finishing barns ("Project"). The Project will house a maximum capacity of 1,440 animal units ("AUs") in the two (2) barns. The Proposer will locate the barns in the SW ¼ of Section 6 of Alton Township in Waseca County. Four (4) of the manure application sites are in Waseca County and one (1) site is in Blue Earth County. All five (5) sites are within approximately eight (8) miles from the Project site.
