Project Title: French Lake Industrial Center

Project Description: The City of Dayton has completed work on an AUAR that examines development of approximately 160.8 acres of land in the eastern portion of the community. The land in question is generally bordered by French Lake to the east and Brockton Lane N. to the west, and is currently made up of open farm fields, wooded areas and wetlands. Complete development of the site would result in seven buildings containing 1.85M square feet of industrial warehousing and distribution space. The proposed uses are supported by the City's Comprehensive Plan and the zoning designation for the property. The EAW Scoping process and comment period did not identify additional scenarios for study, so the single scenario studied by this AUAR focused on the City and Developer's shared vision for the land.

Notice of Permit Decision In the Matter of the Application of Odell Wind Farm, LLC for a Route Permit for the Odell Wind Farm High Voltage Transmission Line Project in Cottonwood, Jackson, and Martin Counties

Public Utilities Commission Docket Number: IP-6914/TL-13-591

In an Order issued on October 29, 2014, the Public Utilities Commission issued a high-voltage transmission line route permit for the Odell Wind Farm High Voltage Transmission Line Project in Cottonwood, Jackson, and Martin Counties. In its Order, the Commission determined that the environmental assessment and record adequately addressed the issues identified in the scoping decision for the project; and authorized Odell Wind Farm, LLC to construct approximately 9.4 miles of 115-kilovolt transmission line and associated facilities in Cottonwood, Jackson, and Martin Counties.

Transgenic Insect Resistant Soybean - Commercial Use Exemption

Monsanto Company has requested an exemption from the Minnesota Department of Agriculture's Genetically Engineered Organism Release Permit for MON 87751, a soybean line which is genetically modified to be resistant several lepidopteran insect pests through the production of insecticidal proteins Cry1A.105 and Cry2Ab2 derived from *Bacillus thuringiensis* subsp. *Kurstaki*. A determination of non-regulated status has been issued by USDA.
