

# Project Title: TH 169/101st Avenue Interchange Project

**Project Description:** The City of Brooklyn Park is proposing construction of a new full access interchange at the TH 169/101st Avenue intersection. Additional project elements include reconstruction of 101st Avenue to a four-lane roadway from Jefferson Highway to Xylon Avenue; addition of auxiliary lanes along TH 169 between TH 610 and the proposed interchange; construction of stormwater ponds; and construction of trails and sidewalks. The project is not currently programmed for construction.

# **Project Title: City of Excelsion**

**Project Description:** The Lake Minnetonka Conservation District (LMCD) is anticipating the receipt of a new multiple dock municipal planned unit development (PUD) license application from the City of Excelsior. The proposal would be to: 1) expand Piers 3, 4 and 5 within their "Commons" area to just under 200' out from the shore, 2) add additional watercraft density, and 3) congregate transient watercraft storage to one specific area. The City of Excelsior is currently approved for 128 BSU on 3,120 feet of 929.4' of shoreline. They are documented as legal, conforming site and maintain a watercraft density of 1:24 through the issuance of a Special Density License. The proposal would be to divide their single multiple dock license into two separate licenses; PUD and Site 2. This EAW reflects the reconfiguration of the proposed PUD license only within the "Commons" area. The City of Excelsior is proposing to dedicate an estimated 2,000 feet of shoreline for the licensed site. Fifty percent of this dedicated shoreline will remain free of structure and storage with a proposed density of 144.

# **Project Title: Brown's Bay Marina (Site 2)**

**Project Description:** The Lake Minnetonka Conservation District (LMCD) is anticipating the receipt of a new multiple dock license application from Brown's Bay Marina (Site 2), located at 1444 Shoreline Drive in Orono, MN 55391. The proposal is to reconfigure the existing non-permanent dock structures utilizing conforming side setbacks and length dimensions; resulting in the repeal of a currently approved variance for both the north and south extended property lines. Brown's Bay Marina (Site 2) is approved for 40 Boat Storage Units (BSUs) on approximately 240 feet of continuous shoreline. This site maintains dock structures and watercraft storage at 1444 Shoreline Drive; however, the shoreline measurements for 1442 and 1440 Shoreline Drive are also dedicated to the density offered at 1444 Shoreline Drive. The site has a BSU density of one for each six feet of continuous shoreline. This proposal would not increase their density.

The final version of the AUAR Update did correct information regarding turning movement counts at the intersection of CSAH 42 and Johnny Cake Ridge Road which did not result in any substantive change to traffic operations.
