Project Description: The Avonlea residential development is proposed on approximately 470 acres of primarily agricultural land in the northern portion of Lakeville. The project proposes 832 single family lots and 249 multi-family lots. Approximately 171 acres of open space is also planned, which will include greenway corridors, parks, trails, wetlands, and stormwater basins.

Project Title: 55th Street Extension and Broadway Avenue North Reconstruction

Project Description: The project includes a new alignment, a new river crossing over the South Fork Zumbro River, and reconstruction of Broadway Avenue North (CSAH 33). Improvements to CR 124 extend eastward for approximately 0.4 mile. The project includes a four-lane expansion of

Scoping Decision Document and EIS Preparation Notice

Project Title: Gateway Corridor Project

Project Description: The Gateway Corridor project is a planned, approximately 12-mile transitway located in Ramsey and Washington Counties. The corridor runs generally parallel to I-94, connecting downtown Saint Paul with its East Side neighborhoods and the suburbs of Maplewood, Landfall, Oakdale, Lake Elmo, and Woodbury. The Gateway Corridor will connect the eastern parts of the Twin Cities Metropolitan Area to the broader regional transit system through Union Depot multimodal transportation hub in downtown Saint Paul.

The Federal Transit Administration (FTA); the Metropolitan Council; and the Washington County Regional Railroad Authority (WCRRA), serving on behalf of the Gateway Corridor Commission (GCC), have initiated the environmental review process for the Gateway Corridor project. Federal funding will be pursued for this project from FTA. As a result, FTA, designated as the lead federal agency for this project, is undertaking environmental review in compliance with the National Environmental Policy Act (NEPA). As the local public agency sponsoring the project, WCRRA is complying with the requirements of the Minnesota Environmental Policy Act (MEPA). The FTA, Metropolitan Council, and WCRRA have determined that the Gateway Corridor project may have significant environmental impacts. To satisfy both federal and state requirements, an Environmental Impact Statement (EIS) is being prepared for the Gateway Corridor project.

A Scoping Booklet was prepared, noticed in the EQB Monitor on March 3, 2014, and distributed to the EQB distribution list and other interested parties. The comment period was open from March 3, 2014 to April 16, 2014. During that time, two public Scoping open houses and a separate interagency Scoping meeting were held.

Since the close of the comment period, WCRRA, in consultation with the Metropolitan Council and FTA, has been reviewing the technical analysis completed and comments received and working through the project advisory committees established for the Gateway Corridor project (specifically, the Technical Advisory Committee (TAC), Policy Advisory Committee (PAC), and Community Advisory Committee (CAC)). WCRRA, acting as the Responsible Governmental Unit (RGU) for the Draft EIS, passed a Scoping Decision Resolution on August 12, 2014.

Based on public and agency input and additional technical analysis, WCRRA has determined that the following alternatives will be evaluated in the Draft EIS:

- No-Build alternative
- Four dedicated bus rapid transit (BRT) alternatives on various alignments (A-B-C-D1-E1, A-B-C-D2-E1, A-B-C-D2-E2, A-B-C-D2-E3) and a managed lane BRT alternative in I-94

A light trail transit (LRT) alternative will not be studied in the Draft EIS.

In addition to the identification of alternatives advanced for further study in the Draft EIS, the Gateway Corridor Scoping Decision Document includes information in compliance with Minnesota Rules, part 4410.2100, subpart 6.

The Scoping Decision Document and EIS Preparation Notice will be distributed to the EQB distribution list and posted on the Gateway Corridor project website (http://thegatewaycorridor.com/). A press release will be provided to at least one newspaper of general circulation within Ramsey and Washington Counties.

Minnesota Department of Agriculture Transgenic Herbicide Resistant Corn and Soybean - Commercial Use Exemption

Dow Agrosciences has requested an exemption from the Minnesota Department of Agriculture's Genetically Engineered Organism Release Permit for the following transgenic events: DAS-40278-9 corn, which is genetically modified to be resistant to phenoxy auxin broadleaf herbicides such as 2,4-D and acetyl coenzyme A carboxylase (ACCase) inhibitor grass herbicides such as quizalofop-p-ethyl; DAS-68416-4 soybean, which is genetically modified to be resistant to 2,4-D and glufosinate, and DAS-44406-6 soybean, which is genetically modified to be resistant to 2,4-D, glufosinate, and glyphosate. A determination of non-regulated status has been issued by USDA and the FDA consultation process has been completed for all three events.
