The Environmental Quality Board is proposing amendments to rules relating to environmental review. This rulemaking will amend rules governing mandatory categories for environmental assessment worksheets (EAW) and environmental impact statements (EIS), definitions to support those categories, responsible governmental unit (RGU) determinations, and categories of exemptions from environmental review. Project Title: Reopen Remaining/Existing Portion of Rum River Campground

Comment Deadline: May 29, 2019

Project Description: This project is the second phase of reopening a campground originally constructed in the mid-1960s and closed in 2002. The first phase, completed in 2014, included rehabilitation of 49 existing campsites. This phase includes rehabilitation of the remaining 147 existing campsites.

Project Title: Bass Ponds EAW

Comment Deadline: May 29, 2019

Project Description: The US Army Corps of Engineers is proposing to improve habitat within the Wilkie Unit of the Minnesota Valley National Wildlife Refuge. The Refuge is located in northern Shakopee and Savage city limits. The area experiences a lack of seasonal variability in water levels which has resulted in reduced wetland habitat quality, aquatic plant diversity, and quality habitat for migratory waterbirds. Water level management features (stoplog structures, earthen plugs) are proposed to improve habitat. The US Army Corps of Engineers have completed the EAW document and Scott County has published the EAW for public review on April 29, 2019. The public review period will end on May 29, 2019 at 4:30 PM. The EAW and related documents are available on-line at www.scottcountymn.gov/BassPondsEAW.
