The Minnesota Department of Commerce (Department) has issued the final environmental impact statement (EIS) for the proposed Huntley to Wilmarth 345 kilovolt (kV) transmission line project in south central Minnesota.

The final EIS analyzes the potential human and environmental impacts of the project and possible measures to mitigate these impacts. It analyzes routing alternatives that could be used for the project and provides a comparative analysis of routing options. The final EIS responds to the comments received on the draft EIS for the project. The final EIS will be used by the Minnesota Public Utilities Commission (Commission) in deciding whether to issue a certificate of need and route permit for the project.

Project Description

Xcel Energy and ITC Midwest LLC propose to construct approximately 50 miles of new 345 kV transmission line from the Wilmarth substation in Mankato, Minn. to the Huntley substation near Winnebago, Minn. The project includes equipment additions and reconfigurations within the Wilmarth and Huntley substations to connect the new 345 kV line. Xcel Energy and ITC Midwest LLC indicate that the proposed project is needed to relieve congestion on the electric transmission grid in southern Minnesota and northern lowa.
