Project Description: Skyline Materials, Ltd. (Proposer) proposes to expand the existing Winnebago Quarry, which currently exists on the west side of Houston County Road 5, to the east side of Houston County Road 5. The Winnebago Quarry is a limestone quarry. The proposed expansion consists of a 27.9 acre area located in portions of Sections 05 and 08 of Winnebago Township, Houston County, Minnesota. The existing quarry plus the proposed expansion have a combined area of 34.4 acres. Project Title: Deer Creek Run, LLC Expansion

Comment Deadline: September 6, 2017

Project Description: Deer Creek Run, LLC (Proposer) proposes to expand its existing swine finishing facility in Section 15 of Frankford Township in Mower County (Existing Facility). The Existing Facility currently houses 830 total animal units (AU) in a total confinement barn. The Proposer will expand the Existing Facility in two phases (Project):

Phase 1: the Proposer will construct a new:

- 87-foot x 230-foot gilt development barn (187.2 AU);
- 170-foot x 305-foot gestation barn (754.4 AU); and
- 196-foot x 241-foot farrowing barn (202.8 AU).
- The Proposer will also replace the existing compost site at the Existing Facility with an 81-foot x 105-foot covered mortality compost bay with 4-foot sidewalls.

Phase 2: the Proposer will construct additions to the Phase 1:

- Gestation barn, with a new 170-foot x 297-foot barn (868.8 AU), and
- Farrowing barn, with a new 185-foot X 196-foot barn (156 AU).

The Existing Facility plus the Project will have a combined total maximum capacity of 2,999 AU. The existing barns have, and the proposed barns will have, steel-reinforced concrete pits for manure storage.
