Environmental Assessment Worksheets

Vermillion River Aquatic Management Area: **Streambank Stabilization**

Comment Deadline: January 13, 2021

Project Description: The Minnesota Department of Natural Resources (DNR) proposes to stabilize a streambank on a section of the Vermillion River. The proposed project is located within the Vermillion River Aquatic Management Area, near the City of Vermillion in Dakota County. The eroding bank of the Vermillion River is affecting wildlife habitat due to increased sediment in the river. Stabilization of 365 feet of streambank would reduce erosion while benefiting fish, aquatic invertebrates and wildlife habitats.

Roseau Lake Rehabilitation & Sprague Creek Wetland Restoration

Comment Deadline: January 13, 2021

Project Description: The Roseau Lake Rehabilitation project would install water control structures, embankments, and a drainage way to allow for water level management in the historic Roseau lakebed. Improved water level management capability would reduce peak flows and adjust timing of outflows of existing storage, which would reduce flooding damage and improve wildlife habitat. Restoration of hydrology at Sprague Creek would provide wetland mitigation for the Roseau Lake Rehabilitation Project.

Final EIS Scoping Decision

Grindstone Dam Removal

Project Description: The DNR proposes to remove the dam on the Grindstone River in Hinckley and restore connectivity to the river channel. This would result in the permanent removal of the 26.6-acre Grindstone Reservoir, which is a public water basin. The removal is proposed because the dam is in poor condition, it presents a safety hazard, and it is a barrier to passage of fish and other aquatic wildlife on the river. The dam also does not allow for natural sediment transport and natural stream features or habitat diversity.

The proposed dam removal requires preparation of an Environmental Impact Statement (EIS). The EIS will describe the potential environmental effects of a proposed dam removal project in the Hinckley area. The EIS scoping documents provide information about the topics that are proposed to be included in the State EIS for the proposed project.

Final Scoping Decision Document (FSDD)

The FSDD describes the final scope of the Grindstone EIS. The FSDD was approved on December 7, 2020. Also included with the FSDD is a Response to Comment (RTC) document, which responds to substantive comments received during public review of the Draft Scoping documents. Previous EIS Scoping Tasks and Documents

The DNR prepared a Scoping Environmental Assessment Worksheet (SEAW) and a Draft Scoping Decision Document (DSDD) for the Project.

The SEAW and DSDD were noticed in the October 12 edition of the EQB Monitor. A 30-day public review and comment period was open October 12 through November 12.

The DNR held an online public information meeting on November 5. The meeting provided information on the project and the EIS scoping process, followed by a question and answer session and a formal, verbal public input session.

Comments received during the 30-day public review and comment period informed the FSDD.

Next Steps

The DNR will prepare a Draft EIS that will be made available for public comment. Another public information meeting will be held during the Draft EIS comment period.
