#### **Project Description**

Xcel Energy and ITC Midwest LLC propose to:

- Build approximately 50 miles of new 345 kV transmission line from the Wilmarth substation in Mankato,
   Minnesota to the Huntley substation, near Winnebago, Minnesota.
- Make necessary modifications to the existing Wilmarth and Huntley substations to accommodate the new 345kV transmission line.

Xcel Energy and ITC Midwest LLC indicate that the proposed project is needed to relieve congestion on the electric transmission grid in southern Minnesota and northern Iowa.

#### **Process Information**

In order to construct the proposed Huntley to Wilmarth project, Xcel Energy and ITC Midwest LLC must obtain two approvals from the Minnesota Public Utilities Commission (Commission) – a certificate of need and a route permit.

Department Energy Environmental Review and Analysis (EERA) staff is responsible for conducting environmental review for certificate of need and route permit applications submitted to the Commission. EERA staff has prepared the above-noted EIS to meet these responsibilities.

The EIS evaluates the potential human and environmental impacts of the project and possible mitigation measures, including routing alternatives. Additionally, the EIS evaluates potential alternatives to the project itself. The EIS does not advocate or state a preference for a specific routing alternative, or for an alternative to the project. The EIS analyzes and compares potential impacts and mitigation measures such that citizens, local governments, agencies, and the Commission can work from a common set of facts. The EIS is issued in draft form so that it can be improved through public comment.

Public hearings regarding the project will be held in the project area the week of January 28, 2019, and will be presided over by Administrative Law Judge Barbara J. Case from the Office of Administrative Hearings. Notice of the hearings will be issued separately. Interested persons will have an opportunity at the hearings to ask questions, provide comments, submit evidence, and advocate for the route(s) that they believe are most appropriate for the project. An evidentiary hearing will be held in St. Paul, Minn., the week of February 4, 2019.

Judge Case will submit a report to the Commission which includes findings of fact, conclusions of law, and recommendations on the certificate of need and route permit applications. The Commission will use the report in deciding whether to grant a certificate of need and route permit for the project.
