Project Title: Eveleth-Gilbert-Virginia Public School Relocations

Comment Deadline: March 4, 2020

Project Description: The Cities of Eveleth, Gilbert, and Virginia, along with the Eveleth-Gilbert School District (ISD 2154) and Virginia School District (ISD 706), plan to consolidate the cities' elementary and high school into an integrated campus with potential to share some facilities like parking and athletic fields. The project will result in the redevelopment of an approximately 201-acre site located east of US 53 and south of Bourgin Road. Construction is planned to begin on the elementary school as early as May 2020 and will open for students by Winter 2021 at the earliest. Construction for the high school will begin in Summer 2020 and be open for students in Fall 2023.

Project Title: TH 169/TH 282/CR 9 Intersection Improvement Project

Comment Deadline: March 4, 2020

Project Description: The City of Jordan, in partnership with the Minnesota Department of Transportation (MnDOT) and Scott County, is proposing intersection and roadway improvements in the area of the TH 169, TH 282, and CR 9 intersection. The improvements include the construction of a new interchange, two bridges, access modifications, sidewalk, and a traffic signal in order to improve vehicle safety and mobility as well as pedestrian and bicycle connectivity. The project is not currently funded; however, the City of Jordan, Scott County, and MnDOT plan to advance this project when funding becomes available.

Project Title: Merriam Junction Sands

Comment Deadline: March 10, 2020

Project Description: Scott County has prepared a draft Environmental Impact Statement for Merriam Junction Sands. The Merriam Junction Sands project is proposing the addition of sandstone mining and processing of silica sand to an existing sand/gravel and limestone mining operation. The project encompasses 682 acres across multiple parcels located in Louisville Township, just south of US Highway 169 and Trunk Highway 41 intersection. The EIS compared 6 different alternatives and a no-build scenario. A public meeting has been set for February 25, 2020 from 4-6 PM at the Scott County Government Center in the County Boardroom. The comment period will be open from February 3, 2020 – March 10, 2020.

Environmental Assessments

Project Title: Great River Energy Lake Eunice HVTL Conversion Project

On June 3, 2019, Great River Energy (GRE) submitted a route permit application to the Minnesota Public Utilities Commission (Commission) under the alternative review process (Minnesota Statute 216E.04; Minnesota Rule 7850.2800-3900). GRE proposes to convert an approximately 0.8 mile portion of GRE's 41.6 kilovolt (kV) LR-LET transmission line to 115 kV standards in Becker County, Minnesota to serve the proposed 115 kV conversion of the Lake Eunice Substation owned by Lake Region Electric Cooperative.

The project is being proposed to improve electrical service to members in the rural area southwest of Detroit Lakes, Minnesota including Lake Eunice, Dunn and Lake View townships. These proposed upgrades will allow over ten miles of 41.6 KV radial transmission to be replaced by a 0.8 mile 115 KV loop fed transmission line. This new line will improve the reliability of the transmission feeding the existing Lake Eunice Substation and thus improve the reliability of the approximate 2,000 members served off of this substation.

After the conversion to 115 kV, the south 0.8 mile and north 2.85 miles of the 41.6 kV conductor will be removed. Lake Region Electric Cooperative will own the remaining 6.59 miles of the 41.6 kV line for distribution purposes and retain all existing distribution lines in the area.

Project Title: Adelmann Family Property

Comment Deadline: March 4, 2020

Project Description: The Adelmann Family Property is located along County State Aid Highway 2 (260th Street East) and I-35, east of Elko New Market in Scott County. The property is comprised of six parcels totaling 242.5 acres which define the AUAR Study Area. Proposed future land uses within the AUAR Study Area include business/limited industrial park (104.7 acres), commercial (93.7 acres), medium density residential (19.3 acres), and public road

right-of-way (24.8 acres). One development scenario, comprised of the following land uses, is proposed: • Business district (10.81 acres) • Business/limited industrial park (57.72 acres) • Highway (gateway) business/commercial district (82.29 acres) • Medium density residential for six townhouses and eight four-plex (7.20 acres) Non-developed acreage will remain as wetlands, wooded/forested, and brush/grassland. Phased development is proposed to occur over several years, beginning with portions of the property located adjacent to the CSAH 2 (260th Street East) corridor.
