Project Title: CSAH 4 Reconstruction Project

Comment Deadline: February 14, 2018

Project Description: Kandiyohi County proposes to reconstruct County State Aid Highway (CSAH) 4 between U.S. Highway 12 and CSAH 10 to improve pavement condition and widen the road to Minnesota Department of Transportation (MnDOT) State Aid Standards. Two segments of CSAH 4 would be realigned, including a segment currently routed through Kandiyohi County Park 3 (Diamond Lake County Park), and a segment of CSAH 26 at the intersection of CSAH 4/CSAH 26. These roadway segments would be realigned outside of

Project Title: Trunk Highway 36 / Hadley Avenue Intersection Improvement Project - UPDATED

Comment Deadline: February 7, 2018

Project Description: The Highway 36 and Hadley Avenue Intersection Improvement Project is located in the City of Oakdale, Washington County, MN. The proposed transportation improvements include the construction of a folded diamond interchange, with a Hadley Avenue bridge over Highway 36, constructing three roundabout intersections, constructing a Gateway State Trail underpass of Hadley Avenue, realigning portions of 55th Street N and Highway 36 Boulevard (north frontage road), and reconstructing pedestrian and bicycle trails along Hadley Avenue.

NOTICE IS HEREBY GIVEN that the Minnesota Public Utilities Commission held its Power Plant Siting and Transmission Line Routing annual hearing on December 22, 2017. An extended comment period has been established to afford interested persons an opportunity to submit comments regarding any matters relating to the siting and routing of Large Energy Facilities.

New Close of Comment Period: Friday, February 9, 2018 at 4:30 pm

Hearing Information

On December 22, 2017, the Minnesota Public Utilities Commission held a public hearing as required by Minnesota Statute § 216E.07. The hearing was presided over by Judge Eric L. Lipman from the Office of Administrative Hearings.

During the hearing, which lasted from 9:30 am until approximately 12:00 pm, Commission staff and the Department of Commerce staff provided an overview of the program and projects pending or completed in 2017. A representative from the Minnesota Department of Natural Resources (DNR) testified on the DNR's involvement and participation in reviewing the permits for these projects.

A number of members from the public offered comments and asked questions about specific projects, or commented in general about the Commission's permit review process and offered suggested improvements to increase public participation in future project review.

The entire hearing was recording as an electronic audio file and this recording can be made available to any interested members of the public wishing to review the hearing testimony. A link to the recording is found here: <https://mn.gov/puc/newsroom/?id=14-321925>.

On November 20, 2017, the Commission issued an official notice of the December 22 hearing, which was efiled in eDockets. The notice was served to a combined service list comprised of all the service lists from all of the 2017 projects. In total, the notice was served to approximately 1000 recipients, but the notice was inadvertently omitted from being published in the EQB Monitor as required by Minnesota Statute § 216E.07.

Commission staff is taking input from the public regarding whether a second hearing is necessary in this docket. If members of the public feel they did not receive enough notification for the December 22, 2017 hearing, because the notice was not published in the EQB Monitor prior to the hearing, please contact Commission staff.

Process Information

The annual hearing is required by Minnesota Statute § 216E.07, which provides that:

The commission shall hold an annual public hearing at a time and place prescribed by rule in order to afford interested persons an opportunity to be heard regarding any matters relating to the siting of large electric generating power plants and routing of high-voltage transmission lines. At the meeting, the commission shall advise the public of the permits issued by the commission in the past year....

Judge Lipman will use information gathered at the public hearing and during the comment period to write a summary report for the Commission.
