The Notice of Adoption to Minnesota Rules 4410 was published in the State Register On December 16, 2019 (<u>SR44N25</u>). The rules become effective five working days after the State Register publishes the Notice of Adoption--**The rules become effective at 11:59pm 12/23/2019.**

# Project Title: Azcon/DSPA-AGP/Northland Slip Sediment Remediation

Comment Deadline: February 5, 2020

**Project Description:** The Minnesota Pollution Control Agency, in partnership with the United States Environmental Protection Agency and the United States Army Corps of Engineers, will hire a contractor to conduct environmental cleanup in the St. Louis River Area of Concern at both the Azcon/DSPA and AGP/Northland Slips. The contractor will dredge contaminated sediment from both slips and dispose of it at an offsite landfill. The contractor will cap remaining contaminated sediments in both slips with armored rock and clean dredge material excavated from the Duluth Harbor.
