Aerial Application of Herbicides - MN Department of Natural Resources Division of Forestry

The MN Department of Natural Resources, Division of Forestry is planning to aerially apply herbicides on state forest lands. Herbicide applications will occur on 226 acres on 5 individual sites. These applications will be used to prepare sites for tree planting and for the release of planted trees from competing vegetation. Aerial application will begin as early as August 1st and finish by September 15th, 2018.
