Alternative Urban Areawide Review Updates

Project Title: TCAAP AUAR Update

Comment Deadline: August 12, 2019

Project Description: The Twin Cities Army Ammunition Plant (TCAAP) Alternative Urban Areawide Review (AUAR) study area is 429 acres located within the broader TCAAP site in Arden Hills. The AUAR study area is bounded by County Road 96 on the south, by Trunk Highway (TH) 10 and Interstate 35W (I-35W) on the west, by State of Minnesota property on the north, and by the National Guard's Arden Hills Army Training Site (AHATS) property on the east. As the Responsible Governmental Unit (RGU), the City of Arden Hills adopted the TCAAP Final AUAR and Mitigation Plan on July 28, 2014. Since the study area has not been fully developed, the purpose of this document is to update the TCAAP AUAR pursuant to Minnesota Rules. Project Title: 2019 Aerial Application of Herbicides for Regeneration of State Forest Land

The MN Department of Natural Resources, Division of Forestry is planning to aerially apply herbicides on state forest lands. Herbicide applications will occur on 786 acres on 21 individual sites. These applications will be used to prepare sites for tree planting and for the release of planted trees from competing vegetation. Aerial application will begin as early as August 15th and finish by September 15th, 2019.
