Project Title: Gateway Mixed-Use Development

Comment Deadline: August 8, 2018

Project Description: This EAW studies the proposed mixed-use project that would result in the redevelopment of an approximately 1.7-acre site, which is currently a surface parking lot bounded by Hennepin Avenue, S 3rd Street, S Washington Avenue, and Nicollet Mall in Minneapolis. Two scenarios (Plan A and Plan B) were evaluated for this site. The two scenarios are as follows: Plan A - approximately 589,700 square feet of office, 9,000 square feet of retail, 280 hotel rooms, 50 attached residential units, and 511 off-street parking spaces; Plan B - approximately 486,750 square feet of office, 15,070 square feet of retail, 140 attached residential units, and 530 off-street parking spaces. The chosen scenario will be constructed during two construction seasons. Copies of the EAW will be available for review at the downtown Minneapolis Central Library located at 300 Nicollet Mall, and in the office of the City's CPED, Land Use, Design and Preservation Section at 250 S. 4th Street, Room 300 Public Service Center. Notice will be published in the EQB Monitor on Monday, July 9th, 2018. Public comments on the EAW must be made within the 30-day comment period, which ends at 4:30 p.m. on Wednesday, August 8th, 2018. It is anticipated that the Zoning and Planning Committee at its regular meeting on September 13th, 2018, or at a subsequent meeting, will receive a report and recommendation from City staff, hear comment from all parties and consider the adequacy of this EAW and the need for an Environmental Impact Statement for this proposal. The City Council would then act on the recommendation of this Committee at a meeting on September 21st, 2018, or at a subsequent meeting. Project Title: Pastoret Terrace Building Demolition

Comment Deadline: August 15, 2018

Project Description: Duluth Economic Development Authority (DEDA) is proposing the demolition of the Pastoret Terrace building located at 109 North 2nd Ave East in Duluth, Minnesota. The Pastoret Terrace building was constructed in 1886 by Michael Pastoret and has been considered a contributing resource to the Duluth Commercial Historic District (DCHD). The building has been modified over the years from its original construction. In 2010, the entire building suffered a fire that left the building vacant of its tenants and has remained vacant and in disrepair since that time. In 2011, the building suffered a second fire resulting in further property damage. The property became tax-forfeit in 2016 at which time DEDA acquired the property from St. Louis County. The building condition has continued to deteriorate beyond feasible rehabilitation, and therefore, the DEDA proposes to demolish it. The City has prepared an EAW to review the potential impacts of the proposed project. The EAW is available for public review and comment starting on July 9, 2018. The City of Duluth will accept written comments on the EAW during the public review and comment period, which concludes Wednesday, August 15, 2018 at 4:00 p.m. Written comments should be submitted to Keith Hamre, City of Duluth, 411 West First Street, Duluth, Minnesota 55802. Alternative Urban Areawide Review Drafts

Project Title: North Dayton Development

Comment Deadline: August 8, 2018

Project Description: This AUAR examines approximately 560 acres of land in the City of Dayton, MN, to analyze the impacts and mitigation measures necessary to accommodate the development of a multi-phased development consisting primarily of single family residential surrounding a core of commercial development. The development density is expected to average approximately 3 units per acre, with 1,500 to 1,700 single-family residential homes and a small commercial node consisting of neighborhood retail. By State statute, this level of development requires a mandatory environmental review, so a Scoping Environmental Assessment Worksheet (EAW) was completed in late 2017, and this Alternative Urban Areawide Review (AUAR) was subsequently prepared in accordance with the findings of that document. The EAW Scoping process and comment period did not identify additional scenarios for study. Copies of the Draft AUAR and mitigation plan have been distributed to agencies listed on the most current Minnesota Environmental Quality Board distribution list for the 30 day comment period. The AUAR and mitigation plan may be accessed by anyone electronically on the City of Dayton's website; and copies are available for review at the Minneapolis Central Branch of the Hennepin County Public Library (300 Nicollet Mall, Minneapolis).
