Merriam Junction Sands FEIS

Comment Deadline: June 15, 2020

Project Description: Scott County has prepared a Final Environmental Impact Statement for Merriam Junction Sands. The Merriam Junction Sands project is proposing the addition of sandstone mining and processing of silica sand to an existing sand/gravel and limestone

mining operation. The project encompasses 682 acres across multiple parcels located in Louisville Township, just south of US Highway 169 and Trunk Highway 41 intersection. The EIS compared 6 different alternatives and a no-build scenario. The comment period will be open from June 1, 2020 - June 15, 2020.
