Project Title: CJ Swine, LLC Swine Facility

Comment Deadline: July 18, 2018

Project Description: CJ Swine, LLC is proposing to construct a swine feedlot facility and house 7,200 swine (2,160 animal units in Section 20, Sweet Township, Pipestone County. CJ Swine proposes to build three total confinement swine finishing barns, each with 8-foot deep concrete liquid manure storage areas below the barn, three stormwater detention ponds, one animal mortality structure, and use existing rural water system lines and a drilled livestock well for livestock water use. CJ Swine will first construct two barns and liquid manure storage areas, and stock up to 4,800 swine, but must apply for and receive a variance from Pipestone County in order to construct the third barn and stock up to 7,200 swine. NOTICE OF JOINT PUBLIC HEARING AND DRAFT SITE PERMIT AVAILABILITY – BITTER ROOT WIND PROJECT

Date: June 28, 2018 **Time:** 6:00 PM

Location: Canby Elementary School, 601 4th Street W, Canby, MN

On October 19 and November 9, 2017 Flying Cow Wind, LLC (Applicant) submitted applications to the Minnesota Public Utilities Commission to construct and operate a large wind energy conversion system (LWECS) in Yellow Medicine County. In order to construct the Bitter Root Wind Project, the applicant must be granted a certificate of need and a site permit from the Commission. The proposed project would entail construction of 44 wind turbines for a combined nameplate capacity of up to 152 megawatts (MW) in Florida, Fortier, and Norman townships in Yellow Medicine County. Facilities associated with the project include underground electrical collection and communication lines, a project substation and interconnection switchyard, an operations and maintenance building, and permanent meteorological towers and gravel access roads. The Commission must approve a certificate of need and a site permit before the project can be built. Flying Cow submitted the certificate of need application in October 2017 and the site permit application was accepted in January 2018. This means the company submitted all the information required to begin the review process. Minnesota Department of Commerce Energy Environmental Review and Analysis staff have issued an environmental report on the project. EERA reviewed public comments received and recommended the Commission issue a draft site permit for the project. A draft site permit is a document prepared for public review and does not permit construction of the project. The Commission issued the draft site permit for the project on May 25, 2018. The public hearing is an opportunity for the public to ask questions and submit recommendations for the Commission's consideration in reaching its decision. After the public hearing and comment period, Administrative Law Judge James E. LaFave will prepare a report for the Commission. The Commission will review all the information in the record and anticipates final decisions on the certificate of need and site permit applications in October of 2018.

NOTICE OF PUBLIC HEARING AND DRAFT SITE PERMIT AVAILABILITY FOR THE BLAZING STAR WIND FARM 2 PROJECT IN LINCOLN COUNTY

Public Utilities Commission (Commission) – Notice of Public Hearing and Draft Site Permit availability on the site permit application for the Blazing Star Wind Farm 2, LLC (Blazing Star 2) wind farm project in Lincoln County, Commission Docket No. IP-6985/TL-17-700. The Commission is providing notice that it will hold Public Hearing on the proposed Blazing Star 2 Wind Farm project at 6 PM on June 28, 2018 at the Hendricks Public School Gymnasium, 200 Lincoln Street, Hendricks, MN 56136.

Blazing Star 2 filed a site permit application with the Commission for an up to 200 megawatt large wind energy conversion system (LWECS). The site permit application was accepted as complete by the Commission in January 2018. The Commission issued a draft site permit on May 11, 2018. The proposed LWECS would be comprised of 57 to 100 wind turbines ranging from 2 to 3.5 megawatts in size and associated facilities that include a project substation, an operation and maintenance building, access roads, meteorological towers, light range or sonic range detecting units, collection and feeder lines, and a temporary laydown area. Associated with this facility, but not part of the wind site permit application, is an approximately 7.5-mile 115-kilovolt (kV) high voltage transmission line (HVTL). The 115-kV HVTL is independently undergoing a review in Commission Docket No. TL-17-701.

Comments on the Blazing Star 2 Draft Site Permit and the project will be received by various methods until July 9, 2018, as noticed. Documents related to this docket can be obtained for the project at the Commission's website at mn.gov/puc, select search eDockets, enter year (17) and the docket number (700), select search. Following the hearing and comment period, an Administrative Law Judge will issue a report and recommendations to the Commission and the Commission will issue a final decision in the late summer or fall 2018.
