Project Title: Trunk Highway (TH) 95 Cambridge Urban Reconstruction Project

Comment Deadline: July 19, 2017

Project Description: The Highway 95 Project proposes to expand and reconstruct approximately 3,000 feet of the existing three-lane highway to an urban four-lane divided highway. The project will retain the existing roadway as a portion of the four-lane design. The project limits extend from just west of Birch Street to approximately Emerson Street in downtown Cambridge. The project also includes improved

pedestrian/bicycle facilities, improved stormwater infrastructure, and relocation of the BNSF rail switch that services industrial developments south of Highway 95.

Project Title: Knife River Naaktgeboren Gravel Pit Expansion

Comment Deadline: July 19, 2017

Project Description: Knife River is proposing an expansion of the Naaktgeboren gravel pit which is an existing 40 acre gravel mining operation. The proposal is to mine up to an additional 41.3 acres of a 131 acre parcel.
