Project Title: Melrose CSAH 13 Bridge Relocation and Sauk River Realignment

Comment Deadline: July 25, 2018

Project Description: The City of Melrose is proposing to remove the Sauk River dam and relocate the CSAH 13 bridge (Bridge No. 7163) in Stearns County, Minnesota to restore natural stream functions and upgrade the bridge, which is functionally obsolete. This will be accomplished through stream realignment, installation of rock arches and bendway weirs, shoreline grading and stabilization, and new bridge construction.

Project Title: Launch Park AUAR

Comment Deadline: July 25, 2018

Project Description: The City of Lakeville has completed an AUAR for two development scenarios on 190 acres in the southeastern portion of the city south of CSAH 50, east of CSAH 23, north of 225th Street, and west of the City of Farmington. The AUAR evaluates two possible development scenarios. These scenarios are in conformance with the City's Comprehensive Plan and include: Scenario 1: 1,900,000sf of office/warehouse. Scenario 2: 2,200,000 sf of office/warehouse and would require a gas line to be relocated to maximize development. The comment period will be from June 25 - July 25.
