The Environmental Quality Board is proposing amendments to rules relating to environmental review. This rulemaking will amend rules governing mandatory categories for environmental assessment worksheets (EAW) and environmental impact statements (EIS), definitions to support those categories, responsible governmental unit (RGU) determinations, and categories of exemptions from environmental review. Project Description: Doran SLV, LLC is proposing a phased multifamily redevelopment of the vacant Walmart site located at 3800 Silver Lake Road (project/site). The site is located in the Silver Lake Village shopping center area. The project proposes two four-story apartment buildings totaling 498 apartment units, over two phases. The project also includes an amenities building, aboveground parking and drop-off, a central courtyard with landscaping, and underground parking.

The original determination was made on 9-6-2017. The Record of Decision was appealed, and the Minnesota Court of Appeals remanded the matter back to MNDNR in June 2018.), 5-21-19 (6-26-2017)
