Project Description: The Central Commons mixed-use development is proposed on approximately 35.3 acres of primarily vacant land. The project proposes construction of a grocery store, convenience store with associated fuel pumps, three retail buildings, a hotel, and an apartment complex. Approximately 13 acres of undeveloped area is also planned, which will include landscaping, buffers, trees, wetlands, and stormwater basins.
