Project Title: Kingsbury Bay - Grassy Point Habitat Restoration Project

Comment Deadline: April 18, 2018

Project Description: The Kingsbury Bay – Grassy Point project sites are located at the upper end of the Duluth-Superior Port, St Louis River Estuary. The Minnesota Department of Natural Resources proposes to mitigate latent contaminated sediments, legacy wood waste, and excessive sedimentation, thereby restoring 240 acres of fish and wildlife habitat within a part of the St Louis River Area of Concern (AOC). Detrimental materials will be removed, contained on-site, or capped in-place. Areas with excess sedimentation will be deepened and the clean materials transported and reused for capping, shallowing, or softening shorelines. Shallow sheltered bay habitats that support productive estuarine marshes of Lake Superior will be restored.

The Minnesota Department of Natural Resources (MNDNR) will accept written comments on the Environmental Assessment Worksheet during the public review and comment period, which concludes on Wednesday, April 18, 2018, at 4:30 p.m. Written comments should be submitted to: Kate Fairman, EAW Project Manager; EWR Environmental Policy and Review Unit; Department of Natural Resources; 500 Lafayette Road; St. Paul, MN 55155-4025.
